#### **ORDINANCE NO. NS-2225**

AN ORDINANCE VACATING THE RIGHT OF WAY OF A PORTION OF ELWOOD LANE AND SKYLINE RANCH ROAD ADJACENT TO THE NEW BEND-LA PINE MIDDLE SCHOOL.

### Findings:

- A. On June 18, 2014, Bryant, Lovlien & Jarvis, PC filed a petition on behalf of the Bend-La Pine School District ("Applicant") to vacate a portion of Elwood Lane and Skyline Ranch Road adjacent to the new Bend-La Pine middle school site.
- B. On July 16, 2014, the City Council directed staff to proceed to process the Petition.
- B. On July 27, 2014 and August 3, 2014, the City published notice of a public hearing on the requested vacation in The Bulletin, a newspaper of general circulation in the City once each week for two consecutive weeks, consistent with ORS 271.110. Within five days after the first day of publication of the notice, the City posted notice of the proposed street vacation, in at least two conspicuous places, at or near each end of the proposed vacation areas. The first publication and posting of the notice occurred not less than 14 days prior to the hearing on the proposed vacation.
- D. The City Council held a public hearing on the proposed vacation on August 6, 2014.
- E. The Petitioner complied with applicable standards and the Applicants have submitted the required number of signatures for the Petition to be approved.
- F. The City Council has determined that the public interest will not be prejudiced by the proposed vacation and that the property should be vacated in exchange for dedication of right of way for the new street alignments as proposed.

### THE CITY OF BEND ORDAINS AS FOLLOWS:

- Section 1. A portion of Elwood Lane and Skyline Ranch Road adjacent to the new Bend-La Pine middle school site is vacated as contained in Exhibits A and B with the following condition:
  - 1. Applicant shall dedicate right of way for the new street alignments as shown in Exhibits A and B.
- Section 2. When the City Manager has certified in writing that the condition has been fulfilled, the City Recorder shall file and record this Ordinance in the Deschutes County Clerk's Office.
- <u>Section 3.</u> If the condition is not fulfilled within one year from this Ordinance's effective date, this Ordinance shall be null and void.


