RESOLUTION NO. 2963

A RESOLUTION ESTABLISHING A PUBLIC ADVISORY COMMITTEE (PAC) TO WORK ON THE INTEGRATED LAND USE AND TRANSPORTATION PLAN FOR THE CENTRAL WESTSIDE OF BEND

Findings:

- A. The City is moving forward with a Transportation and Growth Management-funded planning project for the central west side of Bend. The project includes public outreach, land use and transportation scenario development and evaluation, creation of transportation performance measures, and code and plan amendments.
- B. A Stakeholder Advisory Committee will be formed, consisting of representatives who have signed an IGA with the City of Bend to contribute \$25,000 each (Deschutes County, Bend Park and Recreation District, OSU-Cascade) as well as Cascades East Transit, Commute Options, and the Department of Land Conservation and Development.
- C. An invitation to apply for a position on the PAC was posted on the City's website and forwarded to Neighborhood Associations and other interest groups. The application period was open for three weeks. A total of 38 applications were received.
- D. A Planning Commission subcommittee reviewed the applications and selected 22 applicants. On October 27, the full Planning Commission approved the subcommittee's recommendations.

Based on these findings,

THE CITY COUNCIL OF THE CITY OF BEND RESOLVES AS FOLLOWS:

- Council forms the Public Advisory Committee for the Integrated Land Use and Transportation Plan for the Central West Side of Bend (the PAC).
- 2. The PAC shall provide recommendations to City staff and the consultant team as they develop transportation and land use strategies to enhance west Bend neighborhoods, acting as a liaison between the project leaders and community members, and providing advice on public outreach. The PAC shall provide recommendations to the Planning Commission regarding the Integrated Land Use and Transportation Plan for the Central West Side of Bend.
- The PAC will meet over a 12 to 18 month period. In addition, PAC members will
 participate in public meetings and provide information, as appropriate, to any
 interest groups that they represent.

- 4. The 22 members recommended by the Planning Commission are appointed as the initial members of the PAC. The list of members is attached as Exhibit A.
- 5. This resolution takes effect immediately on passage.
