

Pollutants of Concern: Oil, Sediment, Metals & Phosphates (Soap)

Why is it a problem?

Discharge of commercial vehicle washing wastewater into the storm drainage system is prohibited because it contains pollutants from the cleaning compounds used and/or from the objects or surfaces being cleaned such as engines, wheels and brakes that containing oils, grease, heavy metals, and other substances that can pollute water. Most soap contains phosphates and other chemicals that harm fish and water quality. Even cleaners labeled "biodegradable" and "non-toxic" may be harmful to aquatic life or ground water. In Bend wash water that is allowed to enter a storm drain will either flow directly into the Deschutes River or towards the groundwater that we all drink.



What's Wrong with this Photo?

Wash area is too small and rinse water is draining into the parking area.

What Can You Do to Help Keep Our Waters Clean?

- Remember, only rain in the storm drain. Only wash vehicles in a covered area that drains to an oil water separator. Do not prewash outside this area.
- Ensure wash area is large enough so that all wash water is contained within the wash bay.
- Minimize the amount of water use by using and properly maintaining recycling systems.
- If washing with detergents, use a phosphate free detergent.
- Protect storm drains and use good housekeeping techniques. Good housekeeping includes: spill prevention, control, and cleanup; equipment and storage area inspection; and proper disposal of both hazardous waste and non-hazardous waste.
- Prevent and clean up spills immediately using dry cleanup methods.



Conclusions:

Question 1) Vast majority of attendees work in the landscape and irrigation installation or maintenance field. I estimate about 50% of the attendees were from Central Oregon with the rest coming from west of the Cascades.
