Key Items Discussed

- **Stormwater Master Plan Approval.** The City's first formal Stormwater Master Plan was adopted by City Council on August 6, 2014.
- Stormwater Facility Plan Draft. Wendy Robinson provided an overview of the public Facility Planning Process, and how that ties in with the UGB process and OAR Goal 11 requirements. Wendy Edde provided an overview of the contents of the draft Stormwater Public Facilities Plan. The Planning Commission will review the documents at its work session on October 13th, and at a Public Hearing on November 10. After that it will go to City Council for a second Public Hearing and consideration for adoption. Comments covered distinguishing urban from rural, the scope of the PFP (covering the existing UGB); its relationship with other projects such as the Galveston Street project and COCC campus developments.
- Annual Report Update. Wendy E. will provide a draft of the FY2013-14 annual report a week before the next meeting for Public Advisory Group review.
- Bend Central District MMA Update. Wendy R. provided an overview of the development of the Bend Central District multi-Modal Mixed Use Area plan. She will be providing a presentation to Council on October 15. More information is available at the website: bendcentralmma.org.

Key Items Discussed

- Stream Stewardship Day Slideshow. Stream Stewardship Day was held on August 23, 2014.
- Eagle Project Storm Drain Marking Slideshow. On September 20, 36 volunteers worked for 6 hours and marked over 800 storm drains on Awbrey Butte.
- **COBA Green Industry Conference**. City distributed 50-60 "Better Site Design Manuals" at front table for conference attendees.
- Webinar Updates. Wendy reported on the recent Center for Watershed Protection (CWP) webinar that the City hosted entitled "Local TMDLs and Regional/River Basin TMDLs' held October 8. The next scheduled webinar is the CWP "Retrofitting Existing Stormwater Ponds" to be held November 12, 2014 form 10-Noon in the Eisenhower Training Room.
- Permeable Pavement. Attendees were interested in the potential for the ASCE permeable pavement webinar. It would be more useful to include a walk to show demonstration sites or to pass around the concrete samples. PAG attendees discussed ideas to provide signs for the public to understand where permeable pavement is, potentially best accomplished with stencils or a marker; to develop a fact sheet describing local successes and lesson's learned; to distribute Better Site Design at BPRD lobby, to develop a list of trained contractors and vendors with specific certifications, and to align the specs to provide for success.
- Stormwater Facility Plan Draft. Wendy distributed revised draft Stormwater Public Facilities Plan that incorporated the PAG comments from September and reported on the Planning Commission work session held on October 13th. Wendy took additional comments on the draft. Comments received pertained to the need for a header row repeat to be included on Table 10, and to consider moving the pipe detail tables to the appendix and to make the font consistent with the rest of the report. Wendy Robinson has provided a draft to the DLCD for review as well. A Public Hearing will be held at the Planning Commission meeting on November 10. After that it will go to City Council for a second Public Hearing and consideration for adoption.

- Annual Report Comments. Chris recommended to fix a sentence with missing words under the Effectiveness section on page 3-9: "The City is looking...." Attendees will provide additional comments by or before 9:30 AM on Monday October 20.
- Roundtable. Areas where additional guidance is needed: work to reach out to subs on construction sites who are not following code; determine and communicate how to address that often there is not enough room on site to bring in machinery and subs, and materials without disturbing areas you do not want to disturb; outreach to contractors.

Attending: Tom Headley (Century West), Galen Norgang (DEA), Todd Cleveland (County CDD), Gretchen Palmer (Palmer Homes), Aaron Collett (BPRD), Krista Ratliff (DEQ), David Buchanan, Wendy Edde (City of Bend)

Key Items Discussed

- Introduction of New Members. Wendy shared updates on new volunteers filling vacant positions on the PAG with regards to the large and small business categories, and the Environmental group category. There is still a position open for a Neighborhood Association.
- Program Updates. The Stormwater Annual Report and Stormwater Public Facilities Plan were completed and submitted on time in late 2014. Wendy circulated a copy of the presentation that she gave to the High Desert green Industry Conference entitled "Water Safe Landscaping" targeting landscape design, construction, and maintenance personnel and provided an update on that outreach, and separate coordination with COAR and title companies. City staff are currently preparing budgets for the next two year biennium and working on stormwater rates.
- Watershed Outreach Campaign/Incentive Program Partnership Opportunities.
 City staff are starting an outreach campaign to begin in April and have two runs—
 an April through May/June and an August-October. The first run will be purely
 educational and the second will entail community partners. Partnership ideas
 include partnering with Bend Film for a kids movie contest; working with recycled
 car washes, and businesses within certain categories who agree to train staff
 (tailgate training with sign-in). For equity purposes, all businesses within a
 category that qualify would be provided the choice to participate.
 - When focusing on the pollutant lead, Wendy suggested supporting efforts of proper lead paint handling. COBA has courses and could be a partner; are there others in the region offering courses: Gretchen confirmed that she is the only certifier in Deschutes County. When power washing exteriors of buildings, it is difficult for contractors to collect debris down to 5 micron filters. Harry Homeowner can do whatever he wants when priming with lead according to the law so that could be a good educational target. Lead can be ingested or inhaled. Outreach at paint stores or where pressure washers are rented or sold could be a good target. The

- City is coordinating with other municipalities throughout the state to update outreach on this topic.
- The County's Household Hazardous Waste program could be a good partner, and Upper Deschutes Watershed Council and potentially Bend Park and Recreation, and local colleges.
- Green car washes (recycled).
- Fleet vehicles and those who wash them (fire trucks, enterprise rent-a-car, car dealerships, school buses).
- With regards to sediments, it is hard to get the construction industry to focus on erosion and sediment control. They do visit the COBA print shop and the Planning Center, so those both may be good advertising spots.
 Often the builders who are targeted for education are not on the job site the key is getting to the subcontractors. David suggested targeting material delivery companies such as Shevlin Sand to get to landscaping subcontractors.
- Clean Water Works program. Attendees noted that a plaque or campaign decal for the Clean Water Works program would be useful for those partners to put on their windows. By providing signage, it gives the company ownership of it; brand the campaign with a logo or visual symbol. A cup in the gutter cold become the symbol, keep it clean and simple, fish and water drop. A lot of sites have permits in a box...could place Clean Water Works partner decal in there with a few educational bullet points.
- Most workplaces post minimum wage employee boards and that may be a location for educational materials. Awards such as \$100 gift card or water bills could be considered. Illicit Discharge Complaints Analysis—David indicated that Illicit Discharge Complaints come in spurts—for a while it was carpet cleaners. Often its landscapers.
- Future topics. Potential future topics include credit program review, and timing of updates given the City's switching over of management and budget software; and input on illicit discharge prevention outreach.
- Roundtable Discussion. A brief overview of the City's first enforcement action under Bend Code Title 16 for illicit discharge to a storm drain along with right of way encroachment and nuisance codes was mentioned.

City of Bend Stormwater Quality Public Advisory Group June 30, 2015 Meeting Summary

Attending: Tom Headley (Century West Engineering), Mark Ellington (BPRD), Krista Ratliff (DEQ), Chris Hart-Henderson (Heart Springs Landscape Design LLC), Wendy Edde (City of Bend)

Key Items Discussed

- Program Updates. Wendy provided updates on the passage of the new stormwater budget and rate increase from \$4/ERU to \$5/ERU, as planned to implement the Stormwater Master Plan; that DEQ's new municipal stormwater permit writer Lisa Cox is reengaging the statewide technical advisory committee to provide input on the development of the next Phase II permit which will take the place of the City's currently administratively extended permit for stormwater flowing to the river; the Utility Department's school outreach program conducted in the spring mainly to 6th graders at Miller Elementary covering water, wastewater, and stormwater components (see our City Edition segment at https://www.youtube.com/watch?v=pOXo5ZOrlUc&index=26&list=PLufJOv4LpbfAT2WkINy89WDCrQ9YdFBkE for details).
- Stormwater Pre-campaign Evaluation. Wendy went over the results of the formal pre-Clean Water Works campaign public survey of residents about stormwater that was conducted in April. The survey was conducted by Riley and Associates. One finding was that over 70% of respondents did not know what their stormwater fee is paying for, so the City developed two radio commercials specifically to help improve that understanding together with sending pollution prevention messages. (See http://bendoregon.gov/modules/showdocument.aspx?documentid=23147 and http://bendoregon.gov/modules/showdocument.aspx?documentid=23148). A follow-up survey will be conducted in the fall as the initial year campaign draws to a close.
- Clean Water Works Watershed Outreach Campaign and Incentive Program.
 Attendees received an overview of and provided comments to improve the clean water works programs including outreach materials, radio and television advertisements, the website, draft partnership program, storm drain art contest, BendFilm Commercial Contest, and planned outreach events.
- Credit Program Discussion. Wendy provided an overview of Resolution No. 2660 (Sept. 19, 2007), and asked for attendees to start to consider recommendations for improvements.

Key Decisions/Action Items

- Public Advisory Group members recommended targeting the low hanging fruit for this campaign but future campaigns could include:
 - Landscapers, focusing on water conserving, organic, natural, pesticidefree, sediment reduction
 - Central Oregon Museum
 - Water companies, promote water conservation measures that reduce dry weather flows
 - Green Spot companies (15 or 20 categories)
 - o Dental Office
 - Oil change business
 - Consider adding health to restaurants category
 - Companies focusing on fertilizers/pesticides point of purchase include Ewing, Fowler, Ace, Hardware, Wilco
- Attendees recommended that the City get a signed statement in order for the business/group to participate as a Clean Water Partner.
- PAG members recommended removing "recycled" from the criteria for car washes, and removing the criteria for participation that they have not been in the illicit discharge database in the last two years as you want to encourage those placers to do better.
- PAG members recommended that the criteria for participation is a goal not a requirement....e.g. to have x% received training.
- Attendees selected the fade to blue discount card layout as their favorite. Wendy will recommend this version for formal approval.
- Wendy to contact Gretchen Palmer/COBA with regards to pursuing lead-based paint education partnership.
- Wendy will take the results of the dot exercise to select the preferred storm drain art to the Communications Dept./ABC for consideration in selecting the winners.
- City will not pursue wheel weights at this time. But if possible, pursuing carpet cleaners and pressure washers would be good.
- Wendy will make changes to outreach pieces.
