RESOLUTION NO. 3071

A RESOLUTION AUTHORIZING A CAPITAL LOAN OF \$1,000,000 FROM THE INSURANCE PROGRAM OF THE INTERNAL SERVICE FUND: CITY WIDE ADMINISTRATION TO THE AIRPORT FUND.

Findings

- A. On June 7, 2017 the City Council authorized a settlement that includes the acquisition of infrastructure on the east side of the Bend Municipal Airport.
- B. The Airport Fund does not currently have sufficient resources to pay for the capital expenditures referenced above.
- C. The Insurance and Risk Management Division of the Internal Service Fund has funds available to provide financing for the acquisition of infrastructure.
- D. Interfund loans are allowed under the provisions of Oregon Revised Statutes 294.468.
- E. Execution of the interfund loan is contingent upon final negotiation of the Airport settlement agreement.

Based on these findings,

THE CITY COUNCIL OF THE CITY OF BEND RESOLVES AS FOLLOWS:

- 1. That \$1,000,000 be loaned from the Insurance and Risk Management Division of the Internal Service Fund to the Airport Fund to provide the necessary financing of capital expenditures.
- 2. The loan will be repaid by June 30, 2027 from airport operating revenues including but not limited to building rental, ground and hangar lease, and tie down revenues.
- 3. The loan is to carry an interest rate of 1.3% per annum, with payments due annually by June 30th.
- 4. The scheduled loan amortization is as follows:
