OUR PLAN:


Make progress toward Climate Action Goals established by Council Resolution to reduce:

- Carbon dioxide emissions from City facilities and operations to achieve carbon neutrality by the year 2030
- Fossil fuel use for City facilities and operations by 40% by 2030 and 70% by 2050
- Community wide fossil fuel use by 40% by 2030 and 70% by 2050

HOW DO WE GET THERE?

- Identify energy efficiency and fossil fuel use reduction opportunities within the City
- Further integrate land use and transportation planning to reduce fossil fuel consumption
- Support expansion of Cascades East Transit
- Seek funding for climate action planning and engage the community

BUILDING ON THE RECENT 11.5% REDUCTION IN CITY FACILITY ELECTRICITY USE, THE CITY OF BEND HAS OUTLINED THE FOLLOWING SHORT AND LONG TERM GOALS:



SHORT TERM

- **1.** Selected Ameresco, an Energy Services Company, to identify **energy efficiency and renewable energy projects** for City facilities and operations. Pay back project costs through energy savings.
- 2. Selected Good Company to conduct Community Greenhouse Gas Emissions Inventory for Bend.
- 3. Continued support for employee Transportation Demand Management Incentive Program.
- 4. Continued funding for transit by Central Oregon Intergovernmental Council.
- 5. Secured funding for Community Climate Action Plan (YEAR 1):
 - a. Repurposed Energy Efficiency and Conservation Block Grant funds making \$99.5K available in the 2017-2019 biennial budget
 - b. Received \$100K in grant awards from Oregon Community Foundation & Partners for Places
 - c. The Environmental Center raised an additional \$25K from the local community for the Bend Climate Action Project

LONG TERM

- **1.** Develop City Operations **Strategic Energy Management Plan** and begin implementating projects by Fall of 2019.
- 2. Track strategies in the Transportation System Plan update that will reduce fossil fuel use
- 3. Develop Community Climate Action Plan by Fall 2019
 - a. Hire new sustainability staff to manage climate action program
 - **b.** Perform Community Greenhouse Gas Emmission Inventory
 - c. Conduct other baseline studies and gather best practices and lessons learned from other communities
 - d. Convene Council appointed Climate Action Steering Committee
 - e. Conduct multi-stakeholder outreach and engagement, contract outside facilitation and support as needed
 - f. Translate Community Climate Action Plan into publically accessible tools for ongoing implementation and tracking
