Summary

1. 3:00 Welcome and Background Information

Cassie Lacy, City of Bend, convened the meeting. Cassie provided background on the Community Climate Action Plan, the Climate Action Steering Committee, and the role of the sector working groups. She also provided an overview of the greenhouse gas emissions inventory data that is associated with the transportation sector.

Tyler Deke, MPO Manager, provided an overview of the transportation infrastructure in Bend and an overview of the transportation policy context and how the city conducts transportation planning. He also provided data about transportation in the Bend Community, such as mode share and VMT trends over time.



Mike Riley, CTAC representative, provided an overview of the Transportation System Plan update that is currently underway. He explained the process that the CTAC is undergoing to complete the TSP update and the milestones that have been reached.

Cassie Lacy introduced the participatory portion of the meeting. Cassie introduced the objectives that the Climate Action Steering Committee drafted for the transportation sector of the Community Climate Action Plan, that the working group would be providing feedback on.
