1. Call to Order and Introductions

Policy Board Chair Livingston called the annual Budget Committee meeting of the Bend Metropolitan Transportation Organization (BMPO) to order at 12:13 p.m. with a quorum present (7 of 10). Ms. Campbell arrived at 12:37 p.m. during presentation of the budget message (Agenda Item 4).

Mr. Bryant expressed concern about potential impacts of reducing public outreach efforts.

3. Review Budget Committee Member Term Assignments and Officer Assignments

Ms. Gregor nominated Mr. Davis to serve as Budget Committee Chair for the meeting. Mr. DeBone seconded the nomination. Mr. Davis agreed to serve if elected. Budget Committee members voted unanimously (7/0/0) in favor of Mr. Davis.

Policy Board Chair Livingston passed meeting control to Budget Committee Chair Davis.

4. Receive Budget Message

Mr. Deke presented the draft budget for fiscal year (FY) 2019-2020. He reviewed the definition of an MPO, MPO purpose, who funds the MPO, Bend MPO boundary, FY 2018-2019 key accomplishments and work underway, budget history, FY 2019-2020 issues and opportunities, FY 2019-2020 priorities, major work tasks, and the line item detail. The proposed Bend MPO budget for FY 2019-2020 is broken down below to show appropriations by major work task and by budget category:

Ms. Anderson outlined her data collection responsibilities.

Ms. Gregor read aloud Mr. Vora's written comments regarding the MPO's annual loan from the City of Bend, consulting services vs. in-house support, and limiting unfunded participation to necessary MPO Technical Advisory Committee and Policy Board activities.

Additional Budget Committee concerns included cost of the US 97 Freight Plan, freight and passenger rail service, what "Professional Services—Consulting" (Line 38) covered, why "Professional Services—Other" (Line 41) was increasing in FY 2019-2020, impact of constrained funding on planned projects, importance of an alternative north-south arterial to US 97, and staffing capacity vs. current and future workload levels.

Motion 1 (8/0/0): Ms. Gregor moved that the Bend MPO Budget Committee approve and recommend MPO Policy Board approval of the Proposed Fiscal Year 2019-2020 Bend MPO Budget as presented. Mr. Vodden seconded the motion which passed unanimously.

5. 2019-2020 BMPO Budget – Public Hearing and Adoption

Budget Chair Davis announced the public hearing for the MPO Policy Board to adopt the 2019-2020 Bend MPO Budget was scheduled for Tuesday, April 16, 2019, 12 noon, in Deschutes Services Center – DeArmond Room, 1300 NW Wall Street, Bend, Oregon. Advance public notice of the meeting will be provided as required by budget law.

6. Adjourn
