 The BMPO's Title VI program has three main components: data collection, public outreach and participation, and consideration of protected populations in all decisionmaking processes. Additionally, BMPO maintains a process for handling civil rights complaints.

Describe any changes that were made to the approved Title VI Program during the reporting period:

• <u>Mapping</u> was updated to reflect the most recent U.S. Census data. Andrea Napoli, was added as MPO staff and will be serving as the designated Title VI Coordinator for the BMPO.

• As of February 2019, a new staff member has been added to BMPO on a 0.6 FTE basis: Andrea Napoli, Senior Planner. Andrea will be serving as the BMPO Title VI Coordinator.

• The Title VI Coordinator is a staff planner for the MPO who works under the MPO Manager. The MPO Manager works under the City of Bend Growth Management Director.

Planning

Summarize any transportation projects that identify potential impacts to minority and/or low-income Environmental Justice (EJ) populations (i.e., impacts such as displacements, increased noise, bisecting neighborhoods):

- The projects below have been awarded 2018 BMPO STBG funds by the BMPO Policy Board on 9/18/18. Most projects awarded funds during this reporting period can be characterized as plan updates or studies, as opposed to roadway or modal projects (which this reporting topic refers to). As such, project-level impacts for those funded planning projects are not yet identified.
 - \$149,000 for Cascades East Transit Regional Transit Master Plan Update, Bend area component
 - o \$50,000 for BMPO MTP Plan Update
 - o \$40,000 for ODOT Parkway Study
 - o \$23,000 for BMPO Transportation Safety Action Plan (areas for further study

identified, see below)

- o \$110,000 for Deschutes County ITS Plan Update
- \$110,000 for low cost ITS projects: Includes citywide traffic signal improvements to improve connectivity with ODOTs central signal system. No negative impacts foreseen.
- \$635,000 for city of Bend Street Preservation: Includes inlays, overlays, and surface seals throughout the city, and includes installing curb ramps where needed to meet ADA requirements (for overlays/inlays, only). A number of the overlay/inlay project locations fall within mapped high poverty and minority areas. No negative impacts found resultant of projects.
- o \$70,811 for Wilson/3rd Street traffic signal design: Proposed to include new curb ramps and sidewalk approaches, and countdown timers. No negative impacts foreseen.

Indicate how identified impacts were minimized/mitigated on projects that affected minority and/or low-income populations:

Development of the <u>BMPO Transportation Safety Action Plan</u> is currently underway. Intersections and roadway segments with the highest frequency and severity of crashes have been identified, some of which fall within identified higher poverty and/or minority areas. MPO staff met with other jurisdictional staff to confirm high crash areas that are already being addressed or will be through other projects. Sites needing further study have been identified and are currently being reviewed.

Describe any projects that specifically benefit community cohesion such as: adding sidewalks, improving access to properties that improve access for EJ populations:

• ADA curb ramp and surrounding sidewalk panel improvements from 2018 Street Preservation projects (for overlays/inlays). Many were located in mapped areas with higher than average minority and low-income populations.

Public Outreach/Involvement

Summarize public outreach efforts (e.g. public meetings, hearings, public announcements) used during planning to enhance citizen participation, focusing particularly on minority populations, women, older adults, people with disabilities and low-income populations:

- An extensive, joint public outreach effort for both the BMPO MTP and Bend TSP updates began in May 2018 and extended thru FY 2019:
 - An MPO/City open house and a number of online events were held. Notification
 was provided thru social media, city website, email newsletters, and email blasts.
 Demographic information from willing participants was collected from the public
 comment questionnaires (online and in-person).
 - 4.5% respondents identified as Minority, 10.1% as Disabled, 13% as Senior
 - o <u>Five neighborhood workshops</u> were held for five large geographic areas within the MPO boundary. The 'Core Area' being the most representative of EJ population

concentrations (see "Core Area Project" below). Notification was provided thru social media, city website, email newsletters, and email blasts. Demographic information from willing participants was collected from the public comment questionnaires (online and in-person).

- 9.4% of respondents identified as Minority, 3.3% as Disabled, 40.3% as Senior
- O An <u>'Equity Workshop'</u> was conducted on February 13, 2019 specifically for organizations that represent underserved populations to provide input on/identify transportation issues and needed improvements from their perspectives. Thirteen organizations were invited, representing minority, low-income, disabled, and senior populations. A survey for these organizations to distribute to their individual members was also provided with 91 responses received.
- Planning for the <u>Core Area Project</u> was active this FY. This is primarily an urban renewal project (with a focus on transportation) addressing areas that include low-income/higher minority areas of Bend. It is a city project with MPO staff having assisted in a public outreach event. Public outreach and participation pop-up events have been held outside of popular local businesses and grocery stores for the following EJ population neighborhood areas:
 - o Wilson Ave (18%-30% Minority, 17%-25% Poverty), May 6
 - o Division St (>30% Minority), May 9
 - o Greenwood Ave (>25% Poverty), May 16
 - o Central District (>25% Poverty), May 23
 - o Main open house/community workshop event held at Bend High School, June 15 (located within >25% Poverty and 17%-30% Minority area).

Notification for these events were provided thru:

- o City website (Spanish and English)
- o Social media
- Stakeholder email list, including approximately ten EJ organizations (i.e.: Salvation Army, Boys and Girls Club, Latino Community Association, Central Oregon Disability Support Network, etc.). Emails to Hispanic/Latino organizations sent in Spanish.
- o Mailers to all businesses within study area (Spanish and English)

Provide data collection supporting public outreach decisions to assess special language needs and what services provided:

• The BMPO collects American Community Survey data for Limited English Proficiency (LEP) individuals. According to 2013-2017 ACS data (Table B16004), 2% of individuals in the Bend Urbanized Area meet the definition of LEP. In an effort to establish "reasonable steps" (based on the USDOT four-factor analysis) to ensure that LEP persons have meaningful access to the programs, services, and information provided by the BMPO, the BMPO will upon request provide written and/or oral communications in Spanish. For targeted outreach, materials in Spanish will be provided (note: 87% of our LEP individuals speak Spanish).

 BMPO Technical Advisory Committee and TSP/MTP Citywide Transportation Advisory Committee make-up, public meeting sign in sheets, public comments received from identified interest representatives, and demographic questions included in in-person and online questionnaires for the MTP/TSP Neighborhood Workshops (held throughout Bend and online); stakeholder email lists and outreach to known local organizations representing EJ populations

Describe any effects Title VI public involvement activities had on planning outcomes:

• Input from the Equity Workshop (described on page 3) focused primarily on transit and bike/pedestrian improvements and programs. Key issues and needs identified are summarized in Table 1 below, including information on how the input would be addressed. Note that "Citywide Transportation Framework" is the project list for Bend's Transportation System Plan.

- In FY 2019, there were 13 voting members for the Technical Advisory Committee made up of staff from various agencies and organizations within the BMPO area, as well as public members. Gender and racial profile: 77% male and 23% female, 12 of the 13 members appearing to be White.
- Members of the Policy Board are comprised of representatives from Bend City Council, Deschutes County Board of Commissioners, and ODOT. In FY 2019, the Policy Committee gender ratio was 80% male and 20% female, with all members appearing to be White.
