

2019 – 2021 UPDATE ADA TRANSITION PLAN FOR CURB RAMPS IN PUBLIC RIGHTS-OF-WAY



INTRODUCTION AND PURPOSE

The City of Bend's Accessibility Program is dedicated to periodically updating the City's ADA Transition Plan for Curb Ramps in the Public Rights-of-Way to coincide with the City's Budgeting process. This 2019-2021 update will highlight recent modifications of policies and programs as well as provide information on current and future projects impacting sidewalks and curb ramps across the City.

The <u>2014 ADA Transition Plan for Curb Ramps in the Public Rights-of-Way</u> explained and documented the significate historic work the City had performed to access, prioritize, and fund curb ramps design and construction. This five-section 2019-2021 update will highlight (I) recent policy decisions directly impacting sidewalks, (II) review the City's Streets Divisions activities, (III) review other City Capital Improvement Projects impacting curb ramps and sidewalks, (IV) review the City's curb ramp inventory and, finally, (V) review the City's Barrier Removal Request process facilitated by the Accessibility Program. The 2019-2021 Transition Plan update is subject to change due to funding limitations and other elements that may delay or impact the City's ability to design or construct the projects specified within this Plan.

I. SIDEWALK PROGRAM UPDATE

Since February of 2018, the City of Bend has been undergoing extensive citizen involvement through its process of updating the City's Transportation System Plan (TSP). The TSP process and the creation of a Citywide Transportation Advisory Committee provide an avenue of involvement for various community members. These community members advocate more time and money investments in the City's transportation system affecting not just vehicular travel, but all travel modes, including pedestrian and biking facilities.

In addition, the <u>2019-2021 Council Goals</u> direct staff to begin formulating ideas for a sidewalk program. Depending on future council decisions and funding, approaches may include increased sharing of responsibility for sidewalk maintenance and repair between the City and adjacent property owners by the end of fiscal year 2021 (June 30, 2021).



At the time of writing this 2019 –2021 Transition Plan Update, the City is waiting for direction from the adopted TSP which is anticipated to include direction for sidewalk infill and maintenance priorities. It will also develop funding source recommendations to implement the program. The City's goal is to have a Sidewalk Infill and Maintenance Plan incorporated into standards and codes within one year of TSP adoption which is anticipated to occur July 2020.

II. STREETS & OPERATIONS DEPARTMENT ACTIVITIES

As the 2017 – 2019 Update of the City of Bend's ADA Transition Plan states, Federal Law requires the upgrade of noncompliant curb ramps to current standards during street alteration activities. The City of Bend's <u>Street and Operations Department</u> (Streets Department) annually engages in certain street preservation activities that constitute an alteration, and thus any noncompliant curb ramps are altered to meet current code. Street preservation activities are essential for increasing the number of compliant curb ramps across the city. As stated on page 178 of the <u>2019 – 2021 Adopted Budget</u>, the 2017-2019 biennium witnessed a substantial increase of street preservation funding which leads to the alteration of over 400 curb ramps.

The City's Accessibility Manager continuously works with the Streets Department to determine the number of curb ramps needing alteration based on the proposed Street Preservation list, such as overlays (See **Appendix A**). The proposed list of streets receiving street preservation activities is subject to change, and thus the associated curb ramps are also subject to change. Although this Transition Plan Update covers the fiscal 2019 – 2021 period, **Appendix A** covers three construction seasons because the construction season (May – October, weather dependent) does not directly coincide with the City's fiscal year (June 30th to July 1st). Curb ramps associated with Street Preservation activities are typically altered the year before the scheduled Street Preservation Activity. For example, streets to receive street preservation activities during the 2019 construction year will have some or all of the associated curb ramp alterations completed during construction year 2018. The Streets Department aims to construct or alter approximately 200 curb ramps annually.



CITY OF BEND III. OTHER CAPITAL IMPROVEMENT PROJECTS

The Streets Department is not the only department in the City that can impact the City's right-of-way. The City's Engineering and Infrastructure Planning Department (EIPD) manages capital improvement projects and oversees construction projects impacting the City's right-of-way for various other departments such as the Utility Department, the Growth Management Department, and the Accessibility Program. During the 2019-2021 biennium, EIPD will manage various projects constructing or altering approximately 26,035 linear feet of sidewalk and approximately 219 curb ramps. For a detailed list of these projects, see **Appendix B**.

IV. CURB RAMP INVENTORY

As discussed in the City's ADA Transition Plan and prior Updates, the number of curb ramps throughout the City is constantly fluctuating as new private development, franchise utility maintenance/improvements, and City improvements, such as street overlays and other infrastructure improvements (sewer/stormwater), occur. The City is proficient at capturing alterations and improvements that affect curb ramps constructed by or on behalf of City projects but capturing curb ramps constructed through private development continues to be a challenge. Often curb ramps are constructed but not entered into the system because of delayed inspections due to staffing challenges, or issues with the City's internal documentation process. It sometimes takes three to six months for constructed ramps to be entered into the City's asset management system. The City is in the process of updating and replacing its permitting software. The hope is that the new software package will better track and report curb ramps installed by private development, thus improving the ability of the City's curb ramp inventory. By the next ADA Transition Plan update (2021-2023) the City will more reliably know the number of curb ramps installed or altered by both City crews and private development.

Reporting of curb ramp numbers can be deceptive and not representative of the actual progress nor indicative of the number of existing ramps. City improvements, such as street overlays, will often remove one noncompliant ramp and replace it with two compliant ramps (two perpendicular or parallel ramps depending on right-of-way availability). While this process greatly enhances usability and connectivity, it does not significantly change the numbers. Therefore, the total curb ramp number will increase steadily, but the number of noncompliant curb ramps will not correspondingly decrease at the same rate. As previously mentioned, the reported number of curb ramps is often



CITY OF BEND not reflective of the actual number of existing ramps due to the three to six months' time lapse between actual inspection and system update.

If all anticipated 2019 - 2021 construction occurs a total of 1,604 ramps and approximately 32,770 linear feet of sidewalk will be added throughout the City. These numbers do not represent private development which also add significant number of curb ramps and linear feet of sidewalk. The below table projects how these improvements will impact the City's curb ramp inventory.

V. ACCESSIBILITY PROGRAM'S BARRIER REMOVAL REQUEST PROCESS

The City's Accessibility Program oversees the <u>barrier removal request process</u> that allows individuals with disabilities to make the City aware of existing barriers to travel within the City's right-of-way, such as changes in level, deficient sidewalk conditions, debris or other barriers.

The Accessibility Program is working to address current barrier removal requests, and continues to attempt to resolve requests from 2014 when a local disability advocacy group submitted 147 requests. At that time, the former Council directed staff to look at creating complete accessible corridors. While ideal, using a complete corridor approach does take substantial time and money, hence the slow resolution of these requests submitted in 2014. Of the 147 requests submitted in 2014, currently 84 requests have been closed, and 63 are either planned or open.

Depending on capacity, the Streets Division often alters other curb ramps or right-ofway features determined by the Accessibility Program's barrier removal request process. During the 2018 construction season, the Streets Division resolved six barrier removal requests which included altering eight curb ramps and replacing sidewalk panel(s) due to change in level. All work completed to resolve barrier removal requests

is paid for by the Accessibility Construction Fund. Five out of the six barrier removal requests completed were received during 2018, one of the requests completed was part of a backlog of requests received in 2014. Since the 2019 construction year has not ended at the time of writing this update, complete numbers are not available. Currently, the Streets Division resolved two requests submitted in 2014, one 2017 request, and one 2019 request. It is important to realize that one barrier removal request may require altering anywhere from one to eight curb ramps. Hence, one request does not correlate to altering one feature; for example, the two requests resolved by the Streets Division during the 2019 construction year equated to the construction of six compliant curb ramps. If the Streets Department is unable to perform work on behalf of the Accessibility Program, significant time and additional costs are required to engage private concrete contractors.

If an individual with a disability experiences a barrier to travel within the City's public right-of-way they are encouraged to file a <u>barrier removal request</u>.
