

Appendix G.1

Stormwater Quality Sweeping Plan



City of Bend Stormwater Utility Street Sweeping for Stormwater Plan FY2019-2020 – FY2020-2021



Background. The needs of the stormwater quality program are separate from other sweeping needs. The City Stormwater Utility currently pays for 3 FTE sweeper personnel (based on an agreement to cover the equivalent to 40% of the sweeper program), and has purchased one sweeper, and has set aside money to assist with GPS for improved tracking and recordkeeping. Currently Streets Dept. employs 4 sweeper personnel in total, and one of the 3 FTE stormwater positions is vacant. As such, a plan for stormwater sweeping is appropriate, especially as the storwmater work is now split between the Utility Department and the Streets Department.

Sweeping for stormwater is important for two reasons—first to keep pollutants such as litter and sediment out of the storm drain system. Second some pollutants can also cause clogging of the storm drain facilities. This latter factor is tempered a bit given the extensive Utility O&M program the City has for its catch basin, sediment manhole, and UIC maintenance, but streets are considered part of the conveyance system for stormwater and are thus not charged a fee for impervious surface coverage.

Goals. The goals of the stormwater sweeping program are to reduce localized flooding and stormwater pollutants for receiving waters.

Objectives. The objectives of the stormwater sweeping are to:

- (a) reduce sediments and other pollutants in the area that drains to the river; and
- (b) keep stormwater facilities clear of blocking debris that can result in localized flooding, including larger gross pollutants (trash and debris or leaves that can block inlets) together with smaller pollutants (sediments that can clog dry wells or drill holes, reducing infrastructure life) throughout the City.

Levels of Service Action Plan for Assigned Stormwater Fee Supported Sweepers.


In spring/summer of 2019, the Street Sweeping program used GPS to determine the time needed at current resource levels (3 employees, 3 machines). For the spring cleanup of the entire City a focused effort took 1.5 months. A fall cleanup of the entire City is estimated to take a focused effort of 1 months. Cleanup after three summer thunderstorms took 1.5 weeks for concentrations in hillside areas. Sweeping of the

MS4 area of at least the center lane (given preliminary analysis that did not incorporate efforts to encourage off-street parking), took 2 weeks of focused effort.

Streets Sweeping Program for Stormwater shall:

1) Schedule to sweep the curb lines of each of the public street in the major basins that drain to the MS4 at least once per quarter on a prescheduled basis that allows for proper outreach of timing (e.g., "first two weeks of October, January, April, July", except during those times when temperatures or weather that are documented prohibit sweeping. This area is 53 lane miles. (See figure below). For purposes of regulatory reporting this item will be met if each public street in the major basins that drain to the MS4 are swept on a scheduled basis at least four times per year on a quarterly schedule (given consideration for weather and equipment issues), unless otherwise shown that weather prevented sweeping.



- 2) Sweep in a manner that allows us to inform those that are in the MS4 basin when the sweeper is scheduled to be there so we can get cars off the street for added efficiency (e.g., Utility staff communicating an even/odd parking request for the scheduled two weeks as an interim measure to increase efficiency).
- 3) Sweep the full street in the MS4 area and each street in the rest of the City at a bare minimum of twice per year, at least once in spring and once in fall to keep the street basalt picked up, and timed to keep storm drain gutters clear of fall leaf drop and debris, with priority to known flooding problem areas and bottom of hillsides. Sweep as

needed for storm cleanup to ensure public safety and to pick up sediments and debris carried onto public roadways. Use reader boards and notifications (e.g., door hangers, reverse calls, etc.) to inform public to increase efficiency by encouraging cars off the street and proper trimming of tree and shrubbery limbs to allow access to curb lines.

- 4) To the degree possible, assign specific sweepers to specific employees for improved care and thus efficiency.
- 5) Track stormwater program sweeping through Infor for better record keeping and reporting effectiveness. Continue with GPS tracking to increase efficiency. Track time, locations, amounts of materials collected, and miles spent sweeping with brooms up and brooms down, and sweeping average speed when brooms are down for stormwater sweeping. Also report total amounts of material collected and miles spent brooms down for total sweeping (stormwater and other sweeping). Report both to Stormwater Utility for use in quarterly financial reporting, annual reporting, and performance metrics. GPS maps should be provided as well when available.
- 6) To ensure 3.0 FTE is spent on implementing the stormwater sweeping plan, provide utility program manager with a breakout of time spent sweeping per the stormwater plan and in total (e.g., including time spent sweeping otherwise (e.g., accident cleanup, construction prep, etc.)). If replacements are used, provide their time sweeping per the stormwater plan.
- 7) Funds on resale of equipment purchased by the stormwater utility to be returned to utility for use in future stormwater sweeper program equipment purchases.
- 8) Include stormwater utility program staff in the decisionmaking for which sweeper equipment to purchase with stormwater utility money to ensure high efficiency for water quality goals and stormwater utility needs.
- 9) Streets to purchase an overshot (PB Loader) to assist with efficiency as well as other Streets Department needs and does not need Stormwater Utility assistance for this.

Stormwater Utility shall:

- 1) Prepare the draft annual report incorporating the sweeping data. Provide sweeping data in utility monthly reports.
- 2) Continue to fund the 3.0 FTE Sweeper personnel in the Streets Program for Stormwater Sweeping work.
- 3) Provide continued assistance with prioritization of GPS as needed.
- 4) Work together operationally as needed and requested and jointly approved.
- 5) Are available to assist with notification upon request in advance (e.g., provision of extra reader boards, dispersal of door hangers, robot notification phone calls, social media notifications) to help clear street of cars, overhanging tree branches and basketball hoops.

6) Utility will help with location of pads and potentially costs for ecoblock fencing materials (rough estimate \$5,000 per site) for temporary storage of sweeper spoils, such as the pilot site at Murphy and Brosterhaus, currently under development.


Timing: The City has been working towards improved efficiency for the past few years. The rest of the current biennium will be used to prepare for and ramp up implementation of the street sweeping plan for stormwater, with full implementation expected in the FY2019-20 year and continuing. GPS data will be reported on as it becomes available in coordination with the Fleet and IT Departments. Streets will provide quarterly reports of street sweeping activities to Stormwater Utility as part of payment request and for regulatory reporting.

This plan will be reviewed and updated every biennium or more frequently if needed.

LOOKING TO HIRE A LANDSCAPE **MAINTENANCE SERVICE?**

Ask your landscape maintenance contractor to use these best management practices to help protect our waters, our environment and those you love!

WHY BOTHER WITH BEST MANAGEMENT **PRACTICES?**

Best Management Practices (BMPs) are designed to protect both our streams and underground drinking water quality, and to prevent clogging our stormwater facilities. Implementing BMPs can make a positive difference to help protect our waters, properties, and public health.



BEST MANAGEMENT PRACTICES

- Do not blow or sweep trash, yard debris, soils or chemicals into street or storm drains. Collect and properly dispose of these materials.
- Properly compost or dispose of debris daily.
- Inspect and safely clean onsite landscape stormwater facilities (e.g., rain gardens, swales) to ensure they operate as designed.
- Mow high, often, and with sharp blades.
- Store fertilizers and other chemicals under cover.

- Purchase the least amount of landscape chemicals needed for your site.
- Use integrated pest management practices. For more information visit: www.oregon.gov/ODA/programs/Pesticides/RegulatoryIssues/Pages/IPM.aspx
- Adjust sprinklers to minimize irrigation overspray.
- Check local rules! Never stockpile landscaping material (e.g., dirt, bark chips, sand gravel) in the roadway or on pervious pavement unless your municipality allows it.
- Roots hold soils in place. Plant slopes with dense ground covering plants to prevent erosion.



IMPORTANT MEASURES YOU CAN TAKE

Do **NOT** apply pesticides, herbicides or fertilizers under windy conditions, or when rain, snow, sleet or hail is predicted within the next 48 hours.















WHAT IS WRONG WITH THIS PICTURE?

Common practices such as these can pollute our water:



1. Over spraying fertilizer/pesticides on the sidewalk and applying them under wet conditions.



2. Raking or blowing leaves and grass off yard and into streets.



Leaving pet waste that can carry bacteria to waterways.




Stockpiling landscape material into the street where it can be a driving safety hazard, clog drains, and result in pollution.

FOR HEALTHY WATERS AND HAPPY CUSTOMERS

Landscape maintenance benefits your customers and their landscapes, and also has a big impact on the local watershed.



WHAT'S HARMFUL TO OUR WATERWAYS?

YARD DEBRIS

Yard debris such as grass, leaves, tree needles, and soil can enter storm drain facilities and cause blockages and flooding.

CHEMICALS

Any landscape chemical including pesticides, fertilizers, and oils and fuels from equipment, can contribute to water pollution.

SOIL

Soil that enters waterways can clog fish gills and damage stream habitat.



NEVER LET THEM ENTER STORM DRAINS!

ONLY RAIN DOWN THE DRAIN!





Here's what to avoid:

- Never stockpile landscaping materials (e.g. dirt, bark dust, sand and gravels) in the roadway or on pervious pavement.
- Do not apply pesticides or fertilizers under windy conditions or when rain is predicted within the next 48 hours.
- Don't blow, dump or wash yard debris into the roadway.
- Don't let landscape water runoff into the roadway.
- If yard debris burning is allowed in your area, please don't burn the material near the water's edge.

BEST MANAGEMENT PRACTICES

To help you better serve your customers, here are some simple steps to protect human health, our streams, rivers, and drinking water supplies.



Plant With Purpose

- Plant slopes densely to prevent erosion.
- Build the soil with compost and mulch to produce healthy plants.
- Mow lawns high, often, and with sharp blades. Consider using a mulching lawn mower to improve turf health
- Inspect and clean the landscaped stormwater treatment facilities (e.g., rain gardens, bio-retention, swales) in accordance with their operation and maintenance plan.
- Compost yard debris.
- Use native plants where appropriate.
- Cover or place perimeter sediment controls around landscaping material piles per local requirement timelines to prevent runoff to the stormwater system.

CONSIDER BECOMING AN ECOBIZ CERTIFIED LANDSCAPER! SEE WWW.ECOBIZ.ORG

Minimize Chemical Use

- Pull weeds instead of spraying.
- Use appropriate mechanical and biological controls.
- Purchase only the amount of pesticides and fertilizer that you need for your site.
- Apply spot treatments instead of broad application.
- When needed, use slow-release fertilizers to prevent wash off; consider using organic products.
- Sweep up product that lands on impervious surfaces.

Protect Our Waterways

- Use a buffer strip of native plants between the waterway and the yard to help filter pollutants.
- Plant trees and shrubs near water's edge to provide shade and help keep the water cool.

Read Carefully

- Apply pesticides and fertilizers according to the manufacturer's recommendations and specific soil needs.
- Follow label recommendations to dispose of unused chemicals-it's the law.

Store Thoughtfully

 Store all chemicals under cover to protect from wind and rain.

Landscape Maintenance Fact Sheet



Applicable Performance Standards & Best Management Practices

Pesticides, herbicides and fertilizers contain chemicals that can affect our drinking water supply and the water quality of the Deschutes Rivers. It's important that we keep these chemicals out of the water supply.

Landscape Maintenance

- ◆ Use all reasonable measures to reduce pollutants from entering storm drains (e.g., litter, fertilizers, etc.). **
- Properly dispose of debris daily. ** Do not leave it where it may enter a storm drain.
- Inspect and clean the landscaped storm drainage facilities as needed (inspect at least twice a year) to ensure they operate as originally designed. **
- Avoid blowing trash, yard debris, and dust into streets or gutters. ***

Landscape Irrigation and Lawn Watering (City of Bend Water Customers Only)

- To minimize water waste City of Bend Irrigation hours are from 5:00 PM to 9:00 AM.
- Even address should water on even numbered days and odd address numbers should water on odd numbered days
 of the month.
- Adjust your watering amounts once vegetation is established or as the weather and temperature change.
- Overspray is not allowed; adjust sprinklers heads and automatic sprinkler cycles to avoid dry weather flows.

Pesticides and Fertilizers

- Store and maintain spill cleanup materials near pesticide, herbicides and fertilizers storage areas. **
- Use pesticides, herbicides and fertilizers according to the manufacturer's recommendations. **
- Use integrated pest management practices where appropriate. ***
- Use up pesticide, rinse containers, use rinse water as product. ***
- Purchase only the amount of pesticides and fertilizer you need for your site. ***
- Avoid using metal-based algaecides (copper sulfate) in fountain water. ***
- Do not apply pesticides, herbicides and fertilizers under windy condition. Sweep up overblown product.

Disposal Requirements

Pesticides, Herbicides & Fertilizers (Hazardous Materials)

- Use rinse water as product and dispose of rinsed containers in trash.**
- Dispose unused material as hazardous waste. **

Garden Clippings

♦ Compost or take to landfill. **

Tree Trimming

Chip, if necessary, before composting or sending to landfill. **









