1. Call to Order - Introductions

Chair Livingston called the regular meeting of the Bend Metropolitan Planning Organization (Bend MPO) Policy Board to order at 12 noon on Tuesday, December 15, 2020, with a quorum of member jurisdictions present (3 of 3).

2. Virtual Meeting Guidelines

Ms. Anderson reviewed the meeting guidelines.

3. Public Comment

4. Meeting Minutes

Data: October 20, 2020 (Agenda Attachment A), November 20, 2020 (Agenda Attachment B)

Motion 1 (3/0/0): Mr. DeBone moved approval of the October 20 and November 20, 2020, draft meeting minutes as presented. Ms. Campbell seconded the motion which passed unanimously.

5. 2021-2024 Metropolitan Transportation Improvement Program Amendment

Data: Summary of proposed MTIP amendment (Agenda Attachment C), PowerPoint

Ms. Anderson provided an overview of the proposed amendments and reviewed the comments received. Mr. Townsend provided additional details about the project parameters and funding.

Policy Board concerns included the meaning of "shoring," review process, connection to the larger cycling route, how bike signals work, and improving safety in the Tumalo area.

Motion 2 (3/0/0): Ms. Campbell moved approval of the proposed amendment to the 2021-2024 MTIP as presented. Mr. DeBone seconded the motion which passed unanimously.

6. Surface Transportation Block Grant (STBG) - Project Review and Funding Determination

Data: Memo and project spreadsheets (Agenda Attachment D), public comments (Agenda Attachment E), PowerPoint

Ms. Napoli provided an overview of the presentation, background/timeline, project applications received, scoring criteria, ranking results from staff and TAC, other important considerations (readiness/timing, other funding sources, cost/benefit, level of impact), funds requested, and the TAC funding recommendation per fiscal year (FY). Five of the eight applications submitted were classified as Safe Routes to School (SRTS) projects.

• Bend Mobility Hub Development

Applicant: Central Oregon Intergovernmental Council Type: Transit

Request: \$150,000 (2022), \$150,000 (2023), \$150,000 (2024)

TAC recommendation: \$0

Ms. Breault discussed benefits, match funding options, funding allocations, and outcomes. She noted mobility hubs were referenced in the 2040 CET Transit Master Plan, 2040 Bend TSP (Transportation System Plan), and 2040 MTP (Metropolitan Transportation Plan) Draft.

Policy Board concerns: other amenities available at hubs, electric vehicle stations, potential hub locations.

• Central Oregon Historic Canal Trail - Crossing Safety Improvements

Applicant: Bend Park & Recreation District (BPRD)

Type: Pedestrian

Request: \$64,218 (2021 construction: Blakely, Brosterhous, Ferguson)

TAC recommendation: \$26,000 (2021) and \$38,218 (2022)

Mr. Stroud explained the need to improve three road crossings (Blakely Road, Brosterhous Road, Ferguson Road). He noted this project supported goals in the BPRD Comprehensive Plan, Bend MPO MTP, and Bend TSP.

Policy Board concerns: low-stress network connections.

Type: SRTS

Relaunch Bike Share Program

Applicant: City of Bend & Bend-La Pine School District Type: Cyclist

Request: \$60,000 (2021), \$115,000 (2022), \$70,000 (2023), \$120,000 (2024)

TAC recommendation: \$40,750 (2023)

Mr. Bergh summarized the history of the former bike share program (Zagster), new program parameters, long-term vision to grow micromobility options as part of the Bend TSP, potential sponsors, and how/what/when the program will be implemented.

Policy Board concerns: bike maintenance costs, funding, potential partners/sponsors (Bend High School students), removing \$40,750 in 2023 recommended by the TAC and holding the \$40,750 unallocated.

• <u>SE Brosterhous Road – BNSF Pedestrian Undercrossing, Crosswalk & Path for</u> Caldera High

Applicant: City of Bend & Bend-La Pine School District

Request: \$120,500 (2021), \$180,750 (2022)

TAC recommendation: \$94,500 (2021) and \$142,532 (2022)

Ms. Fraley discussed the need and match funding options.

Policy Board concerns: path location outside the concrete abutments, crossing at new road put in by the school district.

• NE 8th Street sidewalk & crosswalk for Juniper Elementary/Pilot Butte Middle Schools Applicant: City of Bend & Bend-La Pine School District Type: SRTS

Request: \$184,100 (2023 design & construction)

TAC recommendation: \$180,750 (2024)

Ms. Lewis outlined the need, population served, school and park connections, connection to the low-stress network, and match funding options.

• Juniper Elementary – Accessible Trail From Crossing Guard

Applicant: City of Bend & Bend-La Pine School District Type: SRTS

Request: \$50,000 (2023 construction) **TAC recommendation:** \$50,000 (2023)

Ms. Lewis explained the need and match funding options.

• SW Larkwood Drive – Sidewalk for Pine Ridge Elementary

Applicant: City of Bend & Bend-La Pine School District Type: SRTS

Request: \$90,000 for design & construction (2023)

TAC recommendation: \$90,000 (2023)

Ms. Lewis outlined the need and match funding options.

Policy Board concerns: busyness of Larkwood.

NW Wall Street/Idaho Avenue – Curb Extensions for Amity Creek Elementary

Applicant: City of Bend & Bend-La Pine School District Type: SRTS

Request: \$22,500 (2023 design), \$95,000 (2024 construction)

TAC recommendation: \$0

Ms. Lewis discussed the need, surrounding uses, population served, traffic speeds, and match funding options.

Policy Board concerns: possibility of reducing speed to 20 miles per hour in this area.

Additional Policy Board concerns included how eligible entities were identified, rationale for ranking the Central Oregon Historic Canal Trail higher than SRTS projects, amount of STBG dollars available per year, and funding flexibility.

Motion 3 (3/0/0): Mr. DeBone moved to approve the TAC Funding Recommendation as modified by dropping the bike share program in 2023 and leaving \$40,750 unallocated. Mr. Piper seconded the motion which passed unanimously.

7. City of Bend Grant Letter of Support

Data: PowerPoint

Mr. Deke announced the first application cycle of ODOT's new Oregon Community Paths Program was now open. The City is seeking project development funding for replacement of the Drake Park footbridge. The intention is to conduct an alternatives analysis, including an extensive public engagement process, to determine the size and approach improvements. Ms. Lewis provided further details about the need, noting the footbridge was critical to the key routes network just adopted as part of the Bend WSP. The bridge is not currently accessible to its narrow width and rough surface.

Mr. Abbas added that Mirror Pond Solutions and Bend Park and Recreation District would be providing support letters.

Motion 4 (3/0/0): Mr. DeBone moved approval of the Policy Board letter of support as presented. Mr. Piper seconded the motion which passed unanimously.

Mr. DeBone departed at 1:47 p.m., leaving Mr. Doty to represent County interests and maintain a quorum.

8. STBG – CET Funding

Data: PowerPoint

Mr. Deke explained the MPO approved an STBG funding set-aside of \$368,000 in December 2016 for a fixed-route bus. In September 2017, the Policy Board directed holding the \$368,000 in reserve for CET use, contingent on outcomes of the regional transit master plan update. In September 2018, the Policy Board approved using \$134,000 of the set-aside for the Bend area component of the CET Transit Master Plan and holding the \$234,000 balance in reserve for implementing plan priorities. The regional transit master plan was completed and adopted in September 2020. CET would like to apply the \$234,000 toward implementation of the mobility hubs identified in the CET Transit Master Plan and Bend TSP. MPO staff recommended allocating the \$234,000 toward future mobility hub development as match funds for a STIF (Statewide Transportation Improvement Funding) mobility hubs application. Any funds remaining could be used for mobility hub improvements or Hawthorne Station improvements.

Chair Livingston said staff's suggestion would be a good use of the remaining STBG funds.

Motion 5 (3/0/0): Ms. Campbell moved approval to use the balance of the STBG funds awarded to CET as a match for STIF mobility hubs application and any remaining funds for qualified capital improvements for mobility hubs and/or Hawthorne Station improvements. Mr. Doty seconded the motion which passed unanimously.

Ms. Campbell thanked Mr. Livingston and Mr. Piper for their service to the Bend MPO. Mr. Townsend agreed with her sentiments.

Chair Livingston thanked Bend MPO staff for their support.
