Neighborhood Leadership Alliance Land Use Working Group Meeting June 1, 2021

The meeting of the Neighborhood Leadership Alliance (NLA) Land Use Working Group was called to order at 3:00 p.m. on Tuesday, June 1, 2021, online and by phone.

2. Approve Minutes

Member Johnson made a motion to approve the April 8 minutes as submitted. Member Jorgensen seconded the motion. Approved unanimously (5-0).

3. Public Comments

4. Land Use Education Plan

The group made the following recommendations:

- Remove "Holding staff and decision makers accountable" from resource list.
- Remove "Reporting an inaccessible or missing development notification sign" from resource list. Makayla will look into code enforcement having this on their page.
- Remove "Land Use 102" video from resource list. Revisit at the annual review.
- Remove "Land Use Zoning Definitions" from resource list. May revisit after Zoning 101 StoryMap is created.

5. Land Use Education Resources

- Land Use 101 Video Presentation

Staff Oliver played the video for the group. Member Mushel was concerned that the Land Use 101 video included the current Council, which is majority women and didn't

feel it was representative of our community. Group did not want to delay the distribution of the video.

The group made the following recommendations:

- Present to the NLA for adoption at upcoming meeting.
- In anticipation of the Joint Outreach Mailing, create a land use education webpage draft with the video and an explanation of the Land Use Education Plan & Council Goal and a disclaimer about the webpage being under construction. Ensure the Guide to Public Meetings with Developers and Applicants is included on the page.
- Understanding Land Use Waivers & Variances

The group made the following recommendations:

- Keep current waiver example of ABC Construction and add an explanatory statement following as to why this waiver example was approved.
- Change the wording in the bullets under "Variances" section to avoid using "very easy to achieve" and similar. Also change "numerical" to be more explanatory, "it comes down to the numbers identified within the code."
- Add sentence to "Involvement Opportunities" such as "Many times an applicant will submit for waivers/variances in advance."
- o After amendments, submit to the NLA for adoption at upcoming meeting.
- Understanding the Comprehensive Plan

- Under step 3 change bullets to:
 - Satisfy requirements in the Bend Development Code.
 - Project Plans and documents.
 - Application "Burden of Proof"
 - Planning Division documents ("Staff report")
 - Public comments
 - Type III only: Notice of Determination
- Under "Resources to help in the review of the application" change
 "Connect with your neighborhood association" to "Connect with your neighborhood association land use chair"
- Describe that the earliest stage to get involved is code changes/neighborhood public meeting/comprehensive plan.

Member Jorgensen suggested the letter use examples of what the neighbors are concerned about with HB 2001 specific to their neighborhoods.

Staff Leitheiser facilitated a conversation about the duty of staff to respond to public comments and questions on land use matters.
