- Participate in code update processes and vote for advancing energy efficiency in codes
- Develop a home energy score program
- Develop an outreach and educational program about food waste prevention and diversion
- Improve recycling at multifamily residences

Member Welch moved for the ECC to recommend to Council the six items as the prioritize actions being presented to the City Council subcommittee. Member Chokshi seconded the motion, the motion passed (5-2). (Members Isbell and Buckley opposed).
