

RESOLUTION 3278

A RESOLUTION ADOPTING THE CITY OF BEND ADDENDUM TO THE 2021 DESCHUTES COUNTY MULTI-JURISDICTIONAL NATURAL HAZARDS MITIGATION PLAN

Whereas, the City of Bend recognizes the threat that natural hazards pose to people, property and infrastructure within our community; and

Whereas, undertaking hazard mitigation actions will reduce the potential for harm to people, property and infrastructure from future hazard occurrences; and

Whereas, an adopted Natural Hazards Mitigation Plan is required as a condition of future funding for mitigation projects under multiple FEMA pre- and post-disaster mitigation grant programs; and

Whereas, the City of Bend has fully participated in the FEMA prescribed mitigation planning process to prepare the *Deschutes County, Multi-Jurisdictional Natural Hazard Mitigation Plan*, which has established a comprehensive, coordinated planning process to eliminate or minimize these vulnerabilities; and

Whereas, the City of Bend has identified natural hazard risks and prioritized a number of proposed actions and programs needed to mitigate the vulnerabilities of the City of Bend to the impacts of future disasters within the *Deschutes County, Multi-Jurisdictional Natural Hazard Mitigation Plan*; and

Whereas, these proposed projects and programs have been incorporated into the *Deschutes County, Multi-Jurisdictional Natural Hazard Mitigation Plan* that has been prepared and promulgated for consideration and implementation by the cities of Deschutes County; and

Whereas, the Oregon Office of Emergency Management and Federal Emergency Management Agency, Region X officials pre-approved the *Deschutes County, Multi-Jurisdictional Natural Hazard Mitigation Plan* and the City of Bend Addendum contingent upon the official adoption of the participating governments and entities;

Whereas, the NHMP is comprised of four main elements: Basic Plan, Hazard Annex, City Addenda, and Mitigation Resources, collectively referred to herein as the NHMP; and

Whereas, the NHMP is in an on-going cycle of development and revision to improve it's effectiveness; and

Whereas, the City of Bend City Council adopts the Bend Addendum to the 2021 NHMP and directs the City Manager to develop, approve, and implement the mitigation strategies and any administrative changes to the NHMP.

Now, therefore, be it resolved, that the City of Bend adopts the Bend Addendum to the 2021 Deschutes County Multi-Jurisdictional Natural Hazards Mitigation Plan as an official plan; and

Be it further resolved, that the City of Bend will submit this Adoption Resolution to the Oregon Office of Emergency Management and Federal Emergency Management Agency, Region X officials to enable final approval of the *Deschutes County Multi-Jurisdictional Natural Hazards Mitigation Plan*.




