View the current CouncilAll Summary Report. To note in your review:

- Last week, Council received an email regarding concerns related to a letter received by residents of Romaine Village (noted on your report within the "Affordable Housing" category as "Eviction notices"). Lynne McConnell did some investigating, and provided the below summary:
 - o Residents of Romaine Village in SW Bend received a notice within the last weeks that caused significant alarm, leading to a number of emails to Council and staff. Staff were able to confirm that the letter is not an eviction notice and was required by the Park's lender to be sent. The letter stated that the federal eviction moratorium had ended and that in 30 days, residents who are not caught up on rent may be served with an eviction notice. The residents I spoke with as well as the manager were unaware of anyone who was behind on rent. The property manager is considering sending a clarifying letter to residents upon realizing the uncertainty the first one caused. As always, community members who are facing eviction or foreclosure are encouraged to seek help immediately to ensure the best chances to retain their living situation.
