 - Should rotate members to not overburden have an alternate or possibly two people
 - Have meetings with the Councilors (who support the HREC) before taking to full Council – will help with navigation
- Safety Lead
 - Add Public Comment Facilitator and Peer to Peer Support to responsibilities
 - o Turn Internal Communications into Interpersonal Communications
 - o Add "works with Legal team" after the Public Comment Facilitator
- These are distinct roles that require more accountability
- See that action is taken first then have the Subcommittee better define the three new positions
- Write into each leadership position description that they will offer support to the other positions

Member Mitchell moved to remove the word Officer and replace it with Leader or Leadership. Member Dudo seconded the motion, the motion passed unanimously (10-0).

Member Crosswhite move to begin the process of creating the City Council Liaison, Safety Lead, and Communications Lead positions. Member Tran seconded the motion, the motion passed unanimously (10-0).
