### Approval of January Minutes

 Motion approved. Motion to approve made by Heather Simmons and seconded by Alison Hohengarten. Seven approved. None opposed.

#### CDBG 2022 Draft Annual Action Plan

The Annual Action Plan document was distributed to AHAC members. Public hearing to
discuss the Annual Action Plan will take place at the next AHAC meeting in March. The
document is fluid based on contingencies and funding estimates so expect small changes
until the document is finalized and presented to City Council in April. The document is then
submitted to the Department of Housing and Urban Development (HUD) in May.

### Funding Process Debrief

• There were no questions or comments regarding the Evaluation of the 2021-22 Affordable Housing Funding Recommendation Process. The scoresheets were presented.

### Martin v. Boise and the City's Response to Homelessness

- Oshel and Krantz recapped the landmark case (Martin vs. Boise) where the ruling held that
  cities cannot enforce anti-camping ordinances if they do not have enough shelter beds
  available for their homeless population. The decision was based on the Eighth Amendment
  to the U.S. Constitution's prohibition on cruel and unusual punishment. The agreement
  ensures people experiencing homelessness will not be cited or arrested for sleeping
  outdoors when no shelter is available, and the City will continue to take steps to put every
  person experiencing homelessness in Bend on a path to permanent housing.
- Eagan and Krantz discussed the legal framework and the overall approach that the City is implementing to address the homelessness crisis including but not limited to emergency shelter goals, outreach efforts, cleanup of unsanctioned camps, contract negotiations for the Navigation Center, renovations and operations at Division Street, the safe parking program, coordination between the City and Deschutes County, and HB 4123 (2022).

#### Staff Report
