City of Bend Events Meeting: Hayden Homes Amphitheater

Staff from The City of Bend Licensing Division and The Old Mill District met this week to discuss the upcoming concert season at the Hayden Homes Amphitheater. Due to the increased number of shows scheduled this summer, the <u>2022 Hayden Homes Amphitheater Plan</u> was drafted to address the noise complaints directed to the City of Bend offices and Non-Emergency Dispatch.

All noise complaints will be directed to the Old Mill District for appropriate response. Concerts at the venue are not subject to noise level limits between the hours of 7am – 10pm, per Bend Code Chapter 5.50.030 Exceptions. If a concert is delayed and must play past 10pm, a plan is in place for the Old Mill District to request an Emergency Noise Variance Permit from the City of Bend Licensing Division.
