- Meeting with the City Council Stewardship Subcommittee
 - The subcommittee supported the direction of where the ECC wanted to go with the Home Energy Score, but wanted to make sure the ECC was meeting all their goals and actions that are in the Citywide Climate Action Plan (CCAP)
 - Next steps what will the work plan look like to get the policy created

Lacy presented the following updated on the EV Readiness Plan:

- Member Welch and Baunsgard met with City staff to look at the mission, vision and goal setting
- The consultant is working on finalizing what the recommendations in the report draft to be completed by the end of April
- The consultants will present the recommendations and findings at the May ECC meeting

Member Baunsgard presented the following updates on the Reach Code Bill:

- Legislature did not pass the Reach Code
- The Legislature created the Rebuild Task Force (Resilient and Efficient Buildings)
 - Baunsgard has a seat on the Rebuild Task Force representing Central Oregon
 - The Task Force's mission is to meet twice a month to establish building decarbonization policy options for the legislature to consider in future legislative sessions

Member Buckley presented the following updates on the Revolving Loan Fund:

 Met with Craft Three to learn more about programs they have in place to help encourage more Investment in renewable energy – the subgroup would like to meet with other organizations

8. Bike Rack

Member Buckley volunteered to sponsor the Cascade Natural Gas Franchise Agreement bike rack item.

Member Chokshi presented the following updates:

- Homeowners Association (HOA) Rules:
 - o The City does not know how many HOA's are within the City
 - o There is no direct statutory authority and no direct way to reach the HOA's

- Climate Emergency Declaration
 - City Council needs more external reminders and pressure from the ECC, an environmental group, or the community at large

Member Jensen volunteered to sponsor the HOA Rules and Xeriscaping Requirements bike rack item.

Member Welch volunteered to sponsor the No New Natural Gas Hook Ups bike rack item.
