RESOLUTION 3293

A RESOLUTION AMENDING THE AMERICAN RESCUE PLAN ACT COMMUNITY ASSISTANCE GRANT PROGRAM ESTABLISHED BY RESOLUTION NO. 3279

Findings

- A. On November 3, 2021, the City of Bend City Council adopted Resolution No. 3279 Establishing the City's American Rescue Plan Act Community Assistance Grant Program (the "Program"). The Program was originally funded with \$200,000 to help nonprofit entities either recover from the COVID-19 pandemic or provide services to individuals members of the community who were negatively impacted by COVID-19, especially those individuals who were disproportionally impacted.
- B. The City received a total of 11 applications from community nonprofits requesting a total of \$440,400 in grant relief.
- C. On February 28, 2022, the Stewardship Subcommittee held a public meeting to discuss applications and make funding recommendations to the City Manager. After deliberation, the Subcommittee awarded portions of the \$200,000 to five different community nonprofits: Family Kitchen (\$39,645), Shepherd's House Ministries (\$50,000), Family Access Network (\$10,000), REACH (\$50,000), and Dawn's House (\$50,000). The Stewardship Subcommittee indicated that they were interested in funding additional applicants if approved by the full Council.
- D. On March 28, 2022, the Stewardship Subcommittee held a second public meeting to discuss applications. After deliberation, the Subcommittee recommended the award of \$130,000 to three community nonprofits: Boys and Girls Club of Bend (\$50,000), KIDS Center (\$50,000), and Saving Grace (\$30,000).
- E. The Bend City Council now wishes to amend the November 3, 2021, Resolution No. 3279 establishing the Program to allocate an additional \$130,000 to the Program and to authorize the City Manager to enter into grant agreements with Boys and Girls Club of Bend, KIDS Center, and Saving Grace in the amounts recommended by the Stewardship Subcommittee.
- F. There are sufficient monies in the City's ARPA Fund to award the grants as recommended by the Stewardship Subcommittee, and there will be sufficient monies in the Fund after making the awards to fund other Council initiatives and goals.

Now, therefore, based on the above findings,

THE CITY OF BEND RESOLVES AS FOLLOWS:

- Section 1. The Program will be funded with an additional \$130,000 from the City's American Rescue Plan Act Fund. The total Program funding is \$330,000.
- Section 2. The City Manager is authorized to enter into grant agreements with the Boys and Girls Club of Bend, KIDS Center, and Saving Grace in the amounts recommended by the Stewardship Subcommittee on March 28, 2022.
- Section 3. No changes are otherwise made to the Program.
