Infrastructure Funding Tracking Update

Since the last funding update in July, there are several efforts underway to advance the Council goal to track and aggressively pursue federal, state and local funding sources that provide sustainable funding for needed infrastructure:

- The City has decided to pursue becoming a certified Local Public Agency (LPA);
- The City is preparing to submit applications to four different discretionary competitive grant programs;
- The infrastructure funding tracking internal task force is continuing to meet monthly; and
- The City has been selected to participate in the [Local Infrastructure Hub](#) Grant Application Bootcamp.
