Addressing Houselessness in Deschutes County 5-Year Strategic Plan

The Emergency Houselessness Task Force (now in-active) previously drafted a 5-year strategic plan to address houselessness in Deschutes County. The draft plan will be a starting point for Cheyenne Purrington, the new Director of Houseless Strategies & Solutions in the Coordinated Houseless Response Office, to meet obligations of HB4123, which requires a strategic plan within a year of the award of state funding to establish the new Coordinated Houseless Response Office.
