Bend Vision Project Environmental Scan

Envision Bend, sponsor of the Bend Vision Project, is pleased to provide the **updated Environmental Scan** to our Leadership Alliance members, Project Investors and Project Partners. (An earlier version was previewed by a group of reviewers this summer and its findings highlighted in the Vision Project's Snapshot Report.)

As key supporters of Vision Project this report is being made available to you in advance of its general public release later this fall.

The Scan provides a broad overview of emerging trends—global, national, and regional—along with related local information to inform the community's dialogue on the future of greater Bend and

development of a community vision and action plan. While impossible to present all relevant information, it reflects our commitment to a dialogue that is as complete and current as possible.

The Scan will be updated once more before the end of the year, and along with a Community Input Report summarizing findings of all community engagement activities to date, serve as a resource for our Action Teams that will begin their work on the plan early next year.

With its diverse perspectives on the future, we hope that you will find the Scan useful in your own organization's ongoing planning and initiatives.

PROJECT AND PROGRAM UPDATES

Grant Applications Update

This week the City submitted two more applications to competitive grant programs through the Infrastructure Investment and Jobs Act (IIJA):

- Reconnecting Communities Pilot Program to fund construction of the Hawthorne Avenue
 Pedestrian and Bicyclist Overcrossing, and
- Railroad Crossing Elimination Grant Program to fund environmental clearances and preliminary engineering for the Reed Market railroad overcrossing project.

The **Reconnecting Communities** and **Railroad Crossing Elimination** project narratives are included for reference.

In addition to support from City Council, the City also received support from Senator Merkley, Senator Wyden (forthcoming), ODOT, Bend MPO, and Bend Chamber. The Reconnecting Communities grant additionally received letters of support from: Central Oregon LandWatch, Central Oregon Community College, Bend Park & Recreation District, Bend Central District Business Association, Bend La Pine Schools, Oregon State University-Cascades, and over 180 community organizations, local businesses and Central Oregonians. The Railroad Crossing Elimination grant additionally received letters of support from: BNSF Railway, Bend Police and Fire & Rescue, Economic Development for Central Oregon, Central Oregon Builders Association, and Central Oregon Association of Realtors.

For the Reconnecting Communities program, the City applied for funding to support the Hawthorne Overcrossing based on the specific grant criteria for this program (for which Greenwood and Franklin crossings would not be competitive projects). The City applied to take full advantage of this first funding cycle, understanding the CAAB and TBOC recommendations were not yet complete, and knowing these may need to be revisited if the City is awarded funding through the grant program.
