#### WSJ Highlights Employee Experience Manager as the Hot New Job

This **Wall Street Journal article** explores a fast-growing role that the City of Bend added late last year: the employee experience manager. Senior Program Manager Joshua Romero was featured in the article!

"Many companies created the role during the pandemic as many staff shifted to remote-work, struggled with burnout and quit or switched jobs at some of the highest rates in decades," Ray Smith writes.

Employee experience managers advocate for employees in a variety of ways, including (but not limited to) supporting Employee Resource Groups, coordinating professional development opportunities, and more.

The City of Bend (to our knowledge) is the first mid-size city in Oregon to create an employee experience role. This new employee experience and engagement role is an innovative way the City of Bend is investing in employees' success and continuing its progress on the Future of Work Action Plan.
