DEPARTMENT UPDATES

Graffiti Reporting and Removal Process

In light of some increased graffiti activity and complaints, the Transportation & Mobility Department (TMD) provided an overview of the graffiti reporting and removal process.

In general, residents are encouraged to complete a **Service Request Form** for any graffiti or other Cityowned property damage they would like to report (link can be found at the bottom of our **bendoregon.gov** homepage under the "Get in Touch" heading, or under the **Services | File a Complaint or Report tab**). TMD staff will determine next steps and follow up with the resident directly regarding the outcome.

The Service Request Form is the preferred way to report graffiti so we can track trends and have a record of requests and outcomes. If a resident does not have access to internet, they are welcome to

call the main City line at 541-388-5505 and CMO admin staff are happy to assist with completing this form over the phone on behalf of the resident.

Graffiti Reporting/Removal Process:

- 1. Resident completes a **Service Request Form** to report the graffiti.
 - a. Service Request Forms are processed by our Transportation and Mobility Department (TMD) staff.
- 2. Once TMD receives a report of graffiti, staff are scheduled/dispatched to evaluate the graffiti.
- 3. Staff makes evaluation to determine appropriate action, including:
 - a. If the graffiti is inflammatory, derogatory, or offensive in nature and is on public right of way or public property, a work order is created for our landscape crew to paint over the graffiti.
 - b. If the graffiti is not inflammatory, derogatory, offensive, or in a high public visibility area, we work with the Deschutes County Juvenile work crew for them to paint over the graffiti with City provided supplies / paint.
 - c. If the graffiti is on roundabout art, we try to contact the artist or arts in public places staff to coordinate addressing the graffiti.
 - d. Case by case determination of next steps depending on location and type of graffiti.
 - e. In extreme cases we may notify police or file a police report, which may allow the Police Department to build a case for repeat signature taggers caught in action.
- 4. TMD does not address graffiti on private property. Per the City Code 13.40:
 - a. Graffiti (unauthorized markings) visible from premises open to the public, shall be removed by the owner or occupant within 14 days.
 - b. If not removed within 14 days and determined to be "graffiti nuisance property" by Bend PD, PD shall notify the owners of record and/or occupant that the property of the nuisance determination, information on of any graffiti removal assistance programs available, and notification that the graffiti shall be removed within 15 days of notice, weather dependent.
 - c. Violation of the notice is a Class B civil infraction.
