DEPARTMENT UPDATES

First Edition of the Complete Streets Guide

The **Complete Streets Guide** is now available on the City of Bend Engineering Department Standards and Specifications **webpage**. The complete street approach is a philosophy change, shifting from a vehicle centric design to a more human centered design that focuses on the slower speed urban context with comfortable and safe facilities for people walking, biking, and driving.

The Complete Streets Guide provides information on the different complete streets elements to supplement the Bend Development Code and Standards for use by people designing, building, and operating the City of Bend transportation system. This manual:

- Meets the City Council goals to improve equity, safety, public health, and work toward a climate friendly community,
- Provides more information on complete street elements and including elements the city is exploring as pilot projects but has not yet adopted as standard,
- Promotes complete streets practices beyond the minimum requirement, and
- Introduces equity, universal design, and safe systems design approaches.

This manual is a supplement to the TSP, Bend Development Code, and Standards. It is not intended to contradict or override the requirements of the Bend Development Code or Standards; those documents take precedence.
