Malia Finazzo-Krueger – Timber Kiddies Preschool Cont. for Improvement Grant

Please provide description of proposed improvements and the need or problem your project will address:

The move into the preschool was April 28, 2023. I began working hard over that weekend to get the space ready and safe for children on May 1. Being that the building is older, the biggest improvements needed were painting and upgrading some windows, ceiling, and doors. The total cost of that was \$1,300(Receipts attached and still waiting for receipt from the ceiling work). One of the improvements which is a work in progress, is applying for the school to be a licensed center. The school has gone through some tough transitions which have involved licensing. Through the city, we obtained a certificate of occupancy which the whole process for that certificate of occupancy totaled, \$781.11. This was just for the City of Bend Building/Permitting. For Sanitation, it will cost \$265 to submit the plan review and then another \$266 for the Pre-opening inspection. Lead Testing for property water is \$26 Per test and shipping in addition. Secure fencing was done on June 6, 2023, and the total cost was \$2000. Money is still owed for the Fence (\$800). Fagan Wood Chip Co delivered wood chips for the preschool playground on June 26. The cost of the wood chips and delivery was \$840. I have purchased a play structure dome and a water fixture. All the other toys have been garage sale finds. For people to see my business well for advertising, a big sign on the front of the school building still needs to be purchased and installed. The building front is a prime location for many people to see the school with proper signage. I have asked for a quote and am still waiting to receive it. Will attach when I receive it.

Please further describe your need for funding assistance, why are funds needed to support these improvements? Is your business undercapitalized (i.e., unable to access equity and/or traditional debt resources); at risk of leaving the Core Area; won't be able to start operations in the Core Area if improvements aren't made.

Listed below are some big reasons why this funding is highly needed to support the school's improvements. As everyone knows, starting a business takes time and money. I have been trying to recruit for the past 6 months that we have been open. If I cannot get at least 5 more students to enroll, it will make it very difficult to operate. Most of the advertising is through word of mouth. Instagram and Facebook have been other ways I have advertised. A Google Business Profile has been set up along with many reviews. I have opened the preschool to Mom groups on Instagram and Facebook to come and play (for free), so that I can get people in the space to see what is available. I have coordinated with other local businesses to help one another advertise and spread the word about their business as they will get to share mine. My preschool is looking for a steady flow of 3–5-year-olds and would like to have them attend 9-4pm. Right now, I have 4 kiddos enrolled and they are all part time. This makes it very difficult to pay rent and bills. Some money for advertising would be very helpful in recruiting more students.

For the City Improvement Grant, I am asking for \$10,000.


