#### 1. Call to Order and Introductions

Chair Campbell called the meeting to order at 12:05 p.m., with a quorum established.

#### 2. Hybrid Meeting Guidelines

Mr. Deke reviewed the meeting guidelines.

#### 3. Public Comment

John Heylin, Bend resident, requested efforts to address speeding and related safety issues on Greenwood and noted he had heard there may be plans to install temporary barriers, at Greenwood and Harriman, to help address the issue.

#### 4. Meeting Minutes

<u>Materials referenced</u>: November 17, 2023, Policy Board draft meeting minutes (Attachment A in agenda packet)

**Motion 1**: Councilor Mendez moved approval of the November 17, 2023, Policy Board draft meeting minutes as presented. Commissioner Chang seconded the motion which passed unanimously.

#### 5. MPO Budget Committee Community Member Appointment

MPO Staff noted there are currently two openings on the BMPO Budget Committee, and and recommended to reappoint Greg Bryant to serve a two-year term on the committee.

**Motion 2**: Chair Campbell moved to nominate Greg Bryant to serve a two-year term on the BMPO Budget Committee. Commissioner Chang seconded the motion which passed unanimously.

#### 6. STBG Project Status Updates

Andrea Napoli provided a brief history and introduced the Surface Transportation Block Grant (STBG) projects.

Henry Stroud, presented updates on BPRD projects, which consisted of the Gilchrist Bridge Replacement Design Project and the Central Oregon Historic Canal Trail Crossing Safety Improvement Project. Project overview, status, and next steps were noted for each project., Potential considerations related to accessibility, safety, aesthetic, and cost-effectiveness, for the Gilchrist Bridge design were discussed.

Robin Lewis presented updates on City of Bend projects. The presentation included updates on several project, and overviews, statuses, costs, , design considerations, outcomes, and next steps were provided. The Bike Lane Safety Enhancement Project delineators were discussed and included clarification related to cost, selection process, and maintenance considerations.

The City requested reallocation of Colorado Corridor Planning funds to address safety improvements at Colorado and Arizona intersection, with reasoning and plan for reallocation provided. Clarifying questions about recent accidents on the Colorado corridor were also answered.

**Motion 3**: Councilor Mendez moved to approve the reallocation of Colorado Corridor Planning funds to address the safety improvements at the Colorado and Arizona intersection. Commissioner Chang seconded the motion, which passed unanimously.

There was discussion around the sidewalk portion of the Riverfront – Deschutes River Trail project. Clarifications on design options and right-of-way considerations were provided. It was noted that design that supports pedestrian traffic should be considered.

The City requested reallocation of unused funds from the Deschutes River Trail project. BMPO Staff noted there is policy regulating the use of unspent project funds, and that there are currently efforts to reconcile a reduction in grant funds. The Board will receive an update from the BMPO on the grant funding reconciliation process in couple of months. The request for reallocation will be revisited at a later date.

On behalf of Sharon Smith with BLS, Andrea Napoli presented an update on the Safe Routes to School Project, which includes an accessible path from Neff Road to Juniper Elementary School. Project overview, status, safety highlights, and next steps were provided.

#### 7. School Zone Speed Limits & Safety Overview

Janet Hruby presented an update on the School Zone Beacon Project. The presentation included information on locations, usage timeframes, function, purpose, monitoring/maintenance, costs, and future funding needs. Clarification provided about signage, enforcement options, and development of school zones. Discussion included different views on the level of efficacy of the flashing beacons with regard to reducing

speeds. Discussion also included was the need to consider additional options for speed reduction, pros and cons of flashing beacons compared to static signs, and other safety concerns near specific schools.

#### Bend Pedestrian Network Implementation Plan Overview

Janet Hruby provided a truncated (due to time constraints) presentation on the Bend Pedestrian Network Implementation Plan, from the City's Transportation System Plan (TSP). Key background information was provided, including information on data collection and review methods, funding options, process for creating prioritized project list, goals, and next steps. Clarification about limitations with predicting statistics on sidewalk usage. The Board requested City staff return for more in-depth presentation at a future meeting.

#### 10. Other Business

<u>Deschutes County TSP</u>: Commissioner Chang reported that the public comment period for the Deschutes County TSP is now closed; however, special notes (e.g., from City of Bend or BMPO Policy Board) could still be considered. Public input included notable opposition to paved pathway regional connector projects with concerns around homelessness, potential crime, and wildlife migration. It was clarified that the opposing comments were from just a few individuals, whereas the majority of public comments are in support of the connections. Overview of stakeholder input provided to-date and intent to submit stakeholder comments discussed.

<u>2024 Policy Board meeting schedule:</u> Chair Campbell confirmed that meetings will continue to occur on the 3<sup>rd</sup> Friday at 12:00 p.m. for 2024.

<u>Technical Advisory Committee & Budget Committee</u>: Chair Campbell announced openings in the Technical Advisory Committee and the Budget Committee. Update provided on number of applications received to-date. Application deadline will be extended to December 31, 2023. BMPO Staff requested two Board member volunteers to review applications and make recommendations. Chair Cambell and Councilor Mendez volunteered.

<u>Policy Board member meeting topic requests</u>: Councilor Mendez requested an update on the collaboration between the City of Bend and the Central Oregon Intergovernmental Council (COIC) to pursue long-term sustainable transit funding and any opportunities for the Board to support their efforts.

The next scheduled meeting of the Policy Board is January 19, 2024 at 12:00 p.m. It will be a 2-hour meeting.
