Community Development Block Grant (CDBG) is authorized under Title 1 of the federal Housing and Community Development Act of 1974, as amended. The primary objective of the CDBG Program is the development of viable urban communities through:

- The provision of decent housing,
- The provision of a suitable living environment, and



• The expansion of economic opportunities.

The Community Development Block Grant Program is administered at the federal level by the Department of Housing and Urban Development (HUD).

## **National Objectives**

Federal regulations specify that all activities undertaken using CDBG funding must meet at least one of the following national objectives:

- Benefit to low-and moderate-income persons,
- Aid in the prevention or elimination of slums or blight, or
- Meet a need having a particular urgency.

HUD considers persons below 80% AMI low-income and persons at 80% AMI moderate-income. The three national objectives are summarized below:

## 1. Benefit to Low- and Moderate-Income Persons

Under this objective, CDBG-assisted activities must primarily benefit low- and moderate-income persons. The income thresholds for meeting the low- and moderate-income requirement are determined by HUD. Projects funded with CDBG dollars must either:

- benefit all of the residents of a particular area, where at least 51% of the residents are low- and moderate-income,
- benefit specific populations (e.g., homeless persons, elderly persons, or persons living with HIV/AIDS), as long as 51% of those served are low- or moderate-income,
- provide or improve permanent residential structures for low- and moderate-income persons, or
- create or retain permanent jobs, at least 51% of which will be made available to or held by low- and moderate-income persons.

## 2. Elimination of Slum and Blight

Under this objective, CDBG-assisted activities must help to prevent or eliminate slums and blighted conditions. These activities must either:

- prevent or eliminate slums or blight in a designated area in which slums or blighted or deteriorating conditions exist,
- prevent or eliminate slums or blight on a spot basis in an area not located in a slum or blighted area, in cases
  where a specific condition is detrimental to public health and safety, or
- be in an urban renewal area.

## 3. Urgent Need

The Urgent Need category is designed only for activities that alleviate emergency conditions of recent origin that pose a serious and immediate threat to the health or welfare of the community, and for which no other sources of funding are available. An example of an eligible project under this category would be a major flood that causes serious damage to buildings and infrastructure, thereby threatening the safety of occupants or nearby residents.

## **Eligible Activities**

In order to meet local needs within the national objectives, the CDBG Program provides a great deal of flexibility in the eligible uses of CDBG funds. The following is a summary of the range and types of activities that may be funded through the CDBG Program. The summary is not a complete list of eligible activities; please contact the City's Affordable Housing Program for more detailed information regarding the eligibility of specific programs or projects.

## **Basic Eligible Activities**



According to federal CDBG regulations outlined in 24 CFR 570, the basic eligible activities include a variety of uses including public services.

## **Eligible Proposals**

## B.1. What is the organization's background, mission, and service history:

Home More Network (HMN) is a collective of caring local leaders and mentors founded by an unhoused single mother in Bend, OR. Formed as a support network and 501(c)(3), we are focused on simplifying the process of rebuilding from homelessness in the community and with each unique individual.

## WHAT WE DO:

#### HABITAT RESTORATION

- · Clean-up forests and natural areas impacted by dispersed camping and illegal dumping.
- · Help coordinate removal of abandoned vehicles/RV's from forests that pose a threat of fire and vandalism.
- · (UPCOMING) Implement weekly garbage removal services for unhoused neighbors in impacted areas.
- · Connect and streamline communications, services, schedules and donations with service providers as well as mutual aid groups for unhoused neighbors.

#### **HUMANITY RESTORATION**

- $\cdot$  (UPCOMING) Offer low barrier transitional housing via high quality rent-to-own tiny homes on wheels for people that are interested in investing equity in themselves and their future through a 3-year personal development experience.
- · Each participant works through their unresolved details that contributed to current life circumstances.
- · Each participant is matched with 3 to 5 mentors, professionals, life coaches, case managers and volunteers that are dedicated to supporting their successful transition.
- · Each participant has a chance to work toward their personal reintegration plan through education, skill building, apprenticeships and other avenues of supporting their long-term stability.

#### THREE YEAR GOAL:

Have each participant graduating from Home More Network with the option to keep or sell their tiny home on wheels. While the participant will be responsible for a percentage of the unit price, they will also be able to utilize the equity to move forward in growing their lives.



# B.2. Provide a brief description of the organization's financial stability as it pertains to the organization's capacity to successfully complete the project, including a brief financial history and primary funding sources. We have been supporting unhoused neighbors and clean up events at China Hat through donations from small businesses and through collaborative community efforts that included fundraising from 2020-2023. Home More Network gained nonprofit status in March of 2022.

On November 2, 2023, Home More Network secured our first grant funded by Central Oregon Health Council's Deschutes Community Health Project for \$111,000.

This funding has been granted to support Home More Network's "China Hat Integrity Initiative":

- 1) Outreach at China Hat supporting up to 40 households \$50/monthly in financial support
- 2) Vehicle Flex Funding supporting up to 8 households \$3,000/year in vehicle specific financial support
- 3) Personal Development Mentoring supporting up to 3 households \$800/month in mentorship to develop personal and professional skills and aptitude
- 4) Staff Support 3 part time supporting staff members for administrative, case management and outreach roles.
- 5) Maintenance of HMN's Mobile Office/Outreach Delivery Vehicle (1999 Ford F-350 4x4 Ambulance)

HMN Hand Up Grants (HUGs): A one time up to \$1,000 grant per unhoused individual working through an emergency alongside case management with flexible terms.

## C.4. Describe the need or problem your project will address.

HMN Hand Up Grants (HUGs) address the gaps in care in our current system.

HUGs offer flexible support while addressing urgency of needs and opportunities for people experiencing chapters without housing to become active participants in bettering their lives and circumstances. We specifically fill the gaps in care that other organizations can not or do not currently address in our community when people are needing help in emergencies and/or wanting to change their situation.

# C.5. Describe how your project will address the identified need or problem, including project background, project objectives, services to be provided by the project, the populations or areas to be served, and how the funds will be used.

Home More Network's (HMN's) Hand Up Grants (HUGs) offer flexibility while addressing urgency of needs and opportunities for people experiencing chapters without housing to become active participants in bettering their lives and circumstances. We specifically fill the gaps in care that other organizations can not or do not currently address in our community when people are needing help in emergencies and/or wanting to change their situation.

Having lived experience of 2.5+ years in Bend unhoused, there are specific needs that are extremely challenging to work through or find assistance for when already surviving difficult and/or traumatic circumstances.

There are a limited number of local organizations that are structured for actionable steps during emergencies. For example, no nonprofit organizations in town currently assist unhoused people with hotel stays other than Home More Network and a couple of churches operating from restricted benevolence funds. Pacific Source Flexible Funding previously offered "Urgent Housing" of hotel stays with a turn around time of 1-3 days. Since February of 2023, Pacific Source's "Urgent Housing" requests take 6-8 weeks to process. The timing and availability of potentially life saving resources is crucial when timing matters and becomes detrimental when not available as emergencies are often time sensitive in nature. We seek to alleviate suffering by making resources and answers readily available and accessible as



life unfolds.

This flexible grant opportunity helps people experiencing chapters without housing:

- 1) When a crisis strikes and other financial assistance is not available
- 2) That are wanting to improve their circumstances (health, wellness, safety, employment, income, housing, transportation)

Examples of how Hand Up Grants may be utilized:

- Hotel stays as emergency shelter
- Emergency travel for people needing to reunite with family
- Medical needs not covered by OHP (vision/dental)
- Bend Park and Rec memberships
- Gym memberships
- Transportation (Uber or other ride services for transportation to and from work)
- Purchase of work clothes
- Purchase of generator for person living in an RV with winter approaching
- One year of car insurance
- Six months in fuel
- Towing vehicles or RVs
- · Set of tires
- Vehicle repairs (\*If HMN's Vehicle Flex Funding is already at capacity)

Case Managers at HMN walk alongside clients to actively solve problems and work toward goals to exit homelessness and survival mode. We approach problem solving holistically; assessing the unique needs, limitations and extenuating factors to arrive at solutions.

C.6. Describe how your project will address the identified need or problem in a way or to a degree not already being achieved in the community. Please identify any other similar programs or projects and how your project will add to or improve upon existing services.

Home More Network seeks to address the need while also supporting the individual experiencing the circumstances. HUGs approach problem solving from a trauma informed place of care to alleviate compounded stress and suffering.

Some organizations, like REACH, do offer outreach or financial assistance that partially address a need. For example, a set dollar amount toward an outstanding car insurance bill or DMV fee. The problem is that because there are so few organizations that offer this help, the help REACH and other organization can offer is often limited or a small dollar amount, not necessarily able to cover the entire cost.

Why not help people to pay the entire expense when already operating from a state of survival? When in survival mode, the pre-frontal cortex, the portion of the brain responsible for logic and decision making goes offline. We feel the kind, compassionate and most helpful way to address a need is to do so effectively and efficiently.

**C.7.** Describe the ways in which your project will have a long-term impact on the need or problem being addressed. Home More Network is addressing the gaps in care in our current system of houseless assistance by creating new

opportunities for people to work through and grow from difficult chapters.

The impact of addressing the gaps in care not only closes the pit falls people may otherwise fall into along the way, we



are paving the path to brighter futures for both clients and local service providers as a way to address many of the local needs that otherwise go unmet.

By creating opportunities for consistent support rather than occasional, people working toward getting housed are able to begin to focus on planning for their futures as they no longer need to worry about how to get through the night or week.

## C.8. Describe your organization's plan for evaluating the progress of the project toward addressing the identified need or problem.

We compare "progress" on an individual basis as each set of circumstances are unique.

We compare the present client to the past version of their situation, even if it is, "how are they doing today versus yesterday or a week ago?"

We ask, what are the three best possible outcomes per situation and how can we anticipate and support the steps to follow for the individual being served?

We also model progress based on a "simultaneous" rather than linear scale of Maslow's Hierarchy of Needs. With each client we serve, whether in rapport building services like at Outreach Outposts or Hand Up Grants or in moderate- to long-term programs that include ongoing communication and extensive case management (Vehicle Flex Funding and Personal Development Mentoring) we work with clients to address each area of "Fundamental Need" to support "Self-Actualization" or becoming one's greatest version of themselves for their life's purpose.

Home More Network helps to support clients in the following areas of Fundamental Needs as described by Abraham Maslow:

- 1) Physiological: Survival needs Air, food, water, warmth, shelter, hygiene
- 2) Safety/Security: Health, personal property, income, resources
- 3) Love & Belonging: Sense of community, family, relationships, intimacy, feeling connected
- 4) Esteem: Confidence, respect for/by others, freedom, societal status, achievement, recognition
- 5) Cognitive: Education, discovery, awareness

The depth of support in these areas progress as the clients continues with Home More Network.

# C.9. Describe your organization's collaborations with other agencies, including those that serve protected classes under the Fair Housing Act. Briefly explain your organization's history with these agencies, including any measurable outcomes in the last 12 months. What are your expected outcomes for this project?

We work with clients directly and between service providers to help clients get sheltered and become housed. We are working to simplify the process of navigating and applying for emergency shelters for clients that are waiting for referrals to process for rental assistance programs. We are currently developing navigational tools and visual aids that would be distributed to each local organization that assists clients with the goal of becoming housed. So far, members of Stepping Stone Shelter, Central Oregon Villages, Saint Vincent de Paul of Bend and Bethlehem Inn are aware of the work we are doing to streamline finding appropriate shelters given varying circumstances unique to each client or household. We are working to continue to open opportunities for nonprofits to work together in collaboration rather than competition with the goal of serving clients to the best of our collective abilities.

## E.1. Estimate the total number of persons to be served by the project. How many of the total persons served are low-and moderate-income persons?

Home More Network aims to serve at least 96 individuals through Hand Up Grants. We anticipate all 96+ people served will be unhoused, extremely low and low-income persons.

## E.2. Is the project in a slum of blighted area? If yes, describe the population that will be served and the characteristics of the slum or blighted area (if applicable).

Many of the clients we serve live in encampments in and around Bend including China Hat and Juniper Ridge or in town in smaller encampments. The population served are people experiencing chapters without housing that live in tents, vehicles, dilapidated older RV or completely unsheltered in the elements. Some areas that we serve include areas in Bend where multiple households congregate along residential and business corridors. By providing opportunities for people to improve their circumstances, even incrementally, progress adds up when multiplies across the community.

## E.3. Describe how the project will ensure that moderate-income persons do not benefit to the exclusion of low-income persons.

Most unhoused people are extremely low or low income persons. We prioritize supporting the stability of clients we work with long-term so that they may eventually have an enough stability to that they can begin to maintain homes and lives with at least moderate-income earning potential. Moderate income persons would not qualify for Hand Up Grants.

## E.4. Explain the methods used to determine the project benefit. How are the sources used to determine the project benefit documented and maintained?

The methods used to determine the project benefit are by referral, with emergencies ranking as priority and wellness secondary while also adhering as close to possible on a first come first served basis within reason. HMN will provide a triage outline at the beginning of this program explaining this in greater detail.

F.2. Describe the assumptions used to determine the total project cost and the operating budget, including the sources consulted and how costs were determined.

The assumption is based on personal lived experience having lived locally unhoused for 2.5+ years in Bend, OR. Bills and emergencies that exceed \$50 in value are extremely challenging to find help for. Circumstances like a vehicle repair or other significant emergency can quickly become life or death if accompanied with inclement weather if help is not available. \$1,000/individual is a reasonable grant amount to help work through and work toward better chapters ahead.

This request is for one year of services provided. We will aim to grow the grant amounts in following years through other funding opportunities to include options like paying off credit card debts or purchasing a used vehicle.

Any amount toward Hand Up Grants (HUGs) would be a blessing to our community and the unhoused neighbors we serve. We would still seek to offer \$1,000 grants per individual even if offered an award less than the \$96,000 request. We aim to offer Hand Up Grants as a transitional program as we approach the end of the first year of services launched as a broader financial assistance program, as people survive the heat and smoke of summer and prepare for frigid freeing temperatures. \$1,000 is one to two weeks at a hotel. A literal life saver and blessing to those in need.


