ORDINANCE NO. NS-2493

AN ORDINANCE VACATING A PORTION OF COOLEY ROAD RIGHT-OF-WAY

Findings:

- A. On October 20, 2023, Powell Development Co. (Applicant) submitted an application (PLMISC20230606) requesting to vacate a segment of the right of way along the north side of Cooley Road between Scenic Drive and Berg Lane, to facilitate straightening the alignment of Cooley Road for improvements associated with development of an adjacent site to the south.
- B. On December 6, 2023, the City Council accepted the vacation petition and directed staff to proceed to process the right-of-way vacation application.
- C. On January 16, 2024, the Applicant posted notice of the proposed vacation at each end of the proposed vacation area. On January 24, 2024, and January 31, 2024, the City published notice of a public hearing on the requested vacation in The Bulletin, a newspaper of general circulation in the City once each week for two consecutive weeks, consistent with ORS 271.110.
- D. The area of Cooley Road proposed to be vacated is presently in use as a public road. Bend Code 3.80.040 provides that right-of-way in use for right-of-way purposes will not be vacated unless the vacation involves a trade of property and the creation of an alternate right-of-way that will be used in place of the existing right-of-way. Cooley Road is being straightened out in the location of the vacation, and alternate rights-of-way for this straightening have already been dedicated to the public and accepted by the City.
- E. The City received comments from utility providers requesting that a public utility easement be retained for existing utility facilities in the entire area proposed to be vacated. The City Council finds that it is in the public interest to approve the proposed vacation, and to retain a public utility easement for the existing utility facilities.
- F. The City Council held a public hearing on the proposed vacation on February 7, 2024, and found that the right-of-way vacation complied with applicable standards in Bend Code 3.80.040.
- G. The City Council has determined that the public interest will not be prejudiced by the proposed vacation and that the property should be vacated upon fulfillment of the conditions within this ordinance.

THE CITY OF BEND ORDAINS AS FOLLOWS:

Section 1. The right-of-way along the north side of Cooley Road between Scenic Drive and Berg Lane is vacated as described in Exhibits A-1 and A-3, and depicted in Exhibits A-2 and A-4.

- Section 2. A public utility easement is retained over the full extent of the vacated right-of-way on the north side of Cooley Road.
- <u>Section 3.</u> Upon adoption, the City Recorder shall file and record this Ordinance in the Deschutes County Clerk's Office.
- Section 4. If any provision, section, phrase or word of this Ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions that can be given effect without the invalid provision or application.


