EPA Releases Final PFAS National Primary Drinking Water Regulation

On April 10, the EPA released the final rule establishing a national primary drinking water regulation for PFAS. Specifically, the regulations have established an enforceable maximum contaminant level (MCL) for several PFAS chemicals. Public water systems will be required to monitor for and reduce the levels of any included PFAS if they exceed the MCL. Regulatory monitoring will begin in the next three years and water systems will have until 2029 to comply with the MCL. The EPA estimates that compliance with this rule will cost water systems \$1.5 billion annually. Most industry groups believe that estimate is very low and have placed that number as high as \$38 billion annually.

As you know, the City of Bend has detected one of the included PFAS chemicals, perfluoro octanoic acid (PFOA) above the now-final MCL of 4 ng/L (parts per trillion) at our Copperstone Well. An Alternatives Analysis has been initiated with Consor to identify and evaluate the alternatives to remove PFOA from that water source. Results of the study should be available by the end of this year. The cost of treatment to remove PFAS at Copperstone is difficult to estimate but would likely range from \$1M-5M to install. Bipartisan Infrastructure Law funding is available to offset some of these costs but could be difficult to secure. Operating costs due to PFAS regulations will almost certainly increase in the near term and are likely to impact drinking water rates.

Youth Homeless in Deschutes County (CHRO)

With the recent release of **preliminary Point In Time Count** information on April 2nd, CHRO staff reached out to McKinney-Vento Liaisons who work in schools throughout Deschutes County to get a picture of what youth homelessness looks like. It is important to note that the **McKinney-Vento** definition of "homeless" differs from the **HUD** definition, and includes youth who are "doubled-up" or couch surfing, who stay in motels, or trailer parks/camp grounds. It is also important to note that this data is limited to youth ages 0-18, but HUD considers "youth" to be individuals up to the age of 24. See the **McKinney-Vento findings here**.

The Lighthouse Navigation Center March Report

This month's report shares the positive impact of the remodeling work being done at The Lighthouse Navigation Center by the City Facilities team. Phase Two of The Lighthouse's remodel has been going very smoothly, and the upgrade is resulting in a safer, cleaner, healthier environment for all. Prescribed Burns

Bird Bike Pilot Extension

The City of Bend has successfully completed a two-year pilot program aimed at assessing the feasibility of micro-mobility devices, specifically shared electric bikes. Launched in June 2022, the program has had a positive impact in reducing individual car trips and related carbon emissions, garnering widespread support.

The Transportation & Mobility Department is moving forward with the third year of the pilot under the terms of the original pilot program agreement, along with implementing operational refinements.
