2. Land Acknowledgment: COBAAC Volunteer.

a. *City of Bend Land Acknowledgement*

We would like to acknowledge that the beautiful land, known as Bend, Oregon, north to the Columbia River is the original homeland of the Confederated Tribes of Warm Springs. The Confederated Tribes ceded this land in the Treaty of 1855 while retaining regular and customary hunting, fishing, and gathering rights. The Wana Łama (Warm Springs), Wasq'ú (Wasco), and Northern Paiute people inhabited this area in certain seasonal times that clearly established their presence. It is also important to note that the Klamath Trail ran north through this region to the great Celilo Falls trading grounds. This trade route expanded the impact of commerce between Tribal nations. We acknowledge and thank the original stewards of this land. It is our hope that guests continue to honor and care for this land.

Update from Project Leader Berry:

- The City's User Experience (UX) Designer, Riggle is creating a working draft that will function as website for the Accessibility and Equity Kehoe and COBAAC members to review. Leadership Bend cohorts will receive their feedback and make those updates to the website.
- Two portions of the project are progressing while waiting for the website.
- Leadership Bend project team member, Haag, will collect Interviews for qualitative data and Community experience.
 - Manager Kehoe is asking for COBAAC members to share the small list of testimonial questions and add quality responses to the new website.
- Leadership Bend is working with the City of Bend Business Advocate, Mooney, Cascade Business News, and Bend Chamber to produce a series of press releases to advertise the new website in month.
