City of Bend **City Manager Administrative Policy**



Purpose: Guidelines for the City of Bend parking enforcement to maintain traffic flow in off street public parking facilities with compact parking stalls.

Section 1. Compact Parking Stall Definition

Per Bend Development Code 3.3.300, a compact parking stall is defined as measuring eight (8) feet in width and seventeen (17) feet in length.

Section 2. Enforcement to Maintain Traffic Flow in Off Street Public Parking **Facilities with Striped Compact Parking Stalls**

The City has an interest in ensuring the unimpeded movement of vehicles within off street public parking facilities. In order to maintain traffic flow in off street public parking facilities with compact parking stalls, vehicles parking in compact parking stalls must fit into the stalls. The City desires to clarify how to determine whether a vehicle fits into the compact parking stalls.

Section 3. Parking Enforcement

The City is responsible for the regular monitoring of parking time limits and prohibited parking in any parking district ("Parking Enforcement").

Section 4. Parking in a Parking Stall

City code and state statutes require that a vehicle fit in the parking stall in order to be legally parked. If a vehicle is parked in the stall such that the width or length of the vehicle exceeds the limits of the stall, the vehicle does not fit in the stall and is therefore not legally parked.

Section 5. Enforcement to Maintain Traffic Flow in Off Street Public Parking **Facilities**

The vehicle will be determined to fit into a stall if the width of the vehicle is within the painted stall stripes and the length of the vehicle or anything attached to or carried on the vehicle is equal to or less than the end of either line designating the end of the compact parking stall.

Section 6. Other Considerations

No part of a vehicle may exceed the length of the parking stall including, but not limited to, bike racks, bikes, ladder racks, trailers and trailer hitches. When one of these extends past the end of the marked compact parking stall, the vehicle exceeds the length limit for the compact parking stall and may be cited for illegal parking.
