Motion: Commissioner Kitchens motioned to approve the amended HREC March 27, 2024, Draft Minutes, with correction. Commissioner Colgan seconded the motion with the amendment. 5. HREC Chair and Vice-Chair Elections.

Motion to approve Chair and Vice-Chair Positions from March 2024 to March 2025: Unanimously passed by all voting members who attended today's meeting, in person, six (6) and virtually, one (1):

- Commissioner Jeff Kitchens as Chair
- Commissioner Peacock-Biggs as Vice-Chair
- 6. Collaborate with City Staff: The Analysis of Impediments to Fair Housing, Mellissa Kamanya (she, her) Affordable Housing Coordinator.
 - The City of Bend receives funds from HUD: Called the Community Development Block Grant. Performing an Analysis of Impediment for Fair Housing.
 - The purpose is to assess our community and look for discriminatory practices and identify impediment through outreach. To make appropriate recommendations.
 - Of ten months of Community Input 8 months was active community engagements.
 - 350 community members through a survey and around three hundred in face-to face interviews.
 - The three top issues heard:
 - Difficulty for property management company to address tenants housing needs.
 - Limited housing and infrastructure for persons with disabilities.
 - Substandard living conditions.
 - Census data highlighted changes in Bend: Looking at the trends over five years:
 - Race and Ethnicity
 - Persons with disabilities
 - o Income
 - o Poverty
 - o Employment
 - Housing
 - Identifying Disparities: Public Sector; Private Sector; School enrollment and Racial / Ethnic Composition.
 - \circ Access to Social Mobility: Income segregation; Violent crime; Two income earners.
 - Impediment 1 Recommendations:
 - Prioritize services and community investment in areas with concentrations identified.
 - Evaluate City projects for impacts on protected classes and potential displacement.
 - Balance tracts by increasing housing supple in areas outside of concentrations.
 - Create support systems for low-income families moving into high social mobility areas.

- Impediment 2 Recommendations:
 - Create workflows and systems to collect and analyze data.
 - Develop platforms to communicate data with the public.
 - Enhance community partnerships and establish protocol for data collection and sharing.
- Impediment 3 Recommendations:
 - Increase the number of fully accessible dwelling units in Bend.
 - Consider funding for developers to offset additional costs for building fully accessible dwelling units.
 - Identify areas with infrastructure that limit walkability / rollability for persons with disabilities.
- Impediment 4 Recommendations:
 - Increase developer accountability for how their property management's fair housing compliance.
 - Plan to share fair housing data, trends, and community input with developers.
 - Engage with community on fair housing trainings.
 - Collaborate to provide training on how to request reasonable accommodations.
 - Evaluate and improve City policy language.
 - Consider policies regarding the identification and handling of restrictive covenants.
- Impediment 5 Recommendations:
 - Create systems to analyze and publish Bend lending data.
 - Evaluate downpayment assistance fund options for protected data.
 - Partner with local organizations to increase financial literacy and lending readiness.

Questions:

- One of the impediments relating to participation. For the sake of most people of color, we are not quick to have a conversation, putting plans together because we are not trusting. How as a City can we create a more inviting environment for people that tend not to feel safe or address the fact that they have needs. *Housing Coordinator Kamanya:* Establishing trust is the cornerstone of this work. If we do not hear what is happening, we cannot address it. These are difficult things to talk about. It is the goal of the housing department to continue to work and engage with community groups to build trust.
- Wants to see more outreach to the homeless. And look for an alternative standardized housing options, community buildings, tiny house villages and alternative spaces in terms of sheltering. *Housing Coordinator Kamanya:* The Affordable Housing Advisory Committee works with service providers that provide services to our homeless neighbors. There is recognition for the need of more service providers. The Housing Department have two specialists who focus on houselessness alone and deeply embedded in the community. Coordinator Kamanya invited the commissioners to attend an Affordable Housing Advisory Committee where they have regular updates about the work the City is doing with our houseless population and our service partners.

- What is happening with the substandard housing, in your outreach were you able to use any collective data on that and what that looks like? *Housing Coordinator Kamanya:* During our outreach, a community member submitted a photograph of a burned outlet, having electrical fires on their property, and not able to get them fixed. During the winter, half of their house had no electricity. There were reports of accessibility needs and not having an accessible unit to live and causing damage to the property or themselves. Feelings of risk for safety. Property management companies having high turnover and shortage of staff. With the recovery after COVID, there is still a gap. And these issues have fallen under the data collected.
- What can HREC do to help to support your work? *Housing Coordinator Kamanya:* Attending the Affordable Housing Advisory Committee meetings is a first step. Dreaming of a partnership between Affordable Housing and HREC. And staying in communication with each other and combine forces to work on outreach together to establish community trust.
- 7. Fair Housing Council of Oregon: Emily Hammond (she/her), Education & Outreach Coordinator.

The Fair Housing Council of Oregon (FHCO) was formed in 1990. Fighting for housing justice for 34 years. It is a statewide civil rights nonprofit organization, that proactively promotes housing justice, equity, and inclusion.

It is their mission is to end illegal housing discrimination and promote equal access to housing choice through education and enforcement of fair housing law.
