Mirror Pond Fish Passage Advisory Committee Update

The Upper Deschutes Watershed Council (UDWC) provided an update regarding fund raising efforts for the fish passage project at Mirror Pond. In April, UDWC submitted a grant proposal to the Oregon Watershed Enhancement Board (OWEB) to help fund engineering design for the fish passage structure. Two weeks ago, they had a virtual meeting with the regional OWEB grant review team to share more about the project and expect to learn if the proposal will be funded in September.

Additionally, UDWC has had discussions with ODFW about potential funding that may be available later this fall for engineering design, and there is a possibility for more funding from U.S. Fish and Wildlife Service in 2025. All this to say, UDWC is working to put together grant funding to complete the engineering design to have a more shovel-ready project.
