#### **Deschutes County LEAD Program**

The City of Bend Police Department is a key partner in the Deschutes County LEAD program that is being developed to comply with the requirements of HB4002. During this process of developing the program, it was determined by all participating groups that the Deschutes County Sheriff's Office is the most fitting organization to be the lead agency in the LEAD program, both programmatically and as the HB4002 requires funds to be received and controlled by a county entity.

Deschutes County is proud to receive the BDH Grant to participate in the Oregon Behavioral Health Deflection Program as defined in the Oregon State Legislature, HB 4002. This is a collaborative program between law enforcement agencies and behavioral health entities that assist individuals with a substance use disorder, another behavioral health disorder, or co-occurring disorders to create community-based pathways to treatment, recovery support services, housing, case management, or other services. ### **Greenwood Avenue Construction Begins**

Construction for the Greenwood Avenue Quick Build is beginning on Monday, July 29. Users can expect significant delays and full closures with detours on Greenwood Avenue between Wall Street and NE 2nd Street. Work is expected to last through August 14.

Please read this **construction flyer** with dates and project information. Construction on Monday will occur from 7 a.m - 6 p.m. We expect significant traffic delays during the day work hours and night work starting runs 7 p.m. - 6 a.m. with a full road closure of Greenwood Avenue. There will also be a 48-hour full closure of Greenwood in early August. Note that the map dates on the flyer are subject to change.

Traffic control will change each day and night during construction through August 14. Daily website updates will be posted every afternoon/evening with the next day/night's traffic impacts at bendoregon.gov/midtowncrossings.
