Member Bennet

- Conversation around what we were told and discussed when the toolkits and stuff arrived.
- Talked about the navigation between gravel
- o Focused on the 12 key routes and added additional equipment and resources as needed.

• Vice Chair Heylin

- Would the city consider making a universal speed limit conversation
- It is being talked about
 - Statutory requirement and speed study
 - We must post it

Member Hofbauer

- Let's talk about priority and high frequency routes.
 - The winter ops plan 1.2.3 prioritization
 - 4 AM start for group 1 and then 11 AM start for group 2
 - Ability to use on-call contractors if heavy snow
 - 1s and 2s consider the CET bus route.
 - As we become denser, it will shift from snow removal, not snow moving
 - CET winter meeting to come

Memer Diether-Martin

- Priority system are sidewalks a part of that priority
- Roundabouts and bridge crossings we will cover
- Plowing and shoveling is the responsibility of the property owner adjacent
- The trails have IGA's with bend parks and rec and is a combined effort
 - Example Haul Trail
- Director Abbas mentioned, the new equipment and the ability to start helping in the no man's land but still will be working on the priority areas
- o Gravel is also the property owner's responsibility to clean up.

 - The students put together models of their homesteads and presented them at Tower Theater.

- Member Bennet
 - o talked about wanting to get more folx involved at the neighborhood level.
- Vice Chair Heylin
 - o His neighborhood district used the party trailer and had an ice cream social
