2. Bend Urban Renewal Agency Budget Adjustment (20 minutes) – Allison Platt & Ryan Oster

The City recently received a construction bid estimate for the NE 2nd Street Improvements that were higher than anticipated. The costs for 2nd Street exceed what BURA can fund; unless funding allocations amongst projects in the BURA Core Area Capital Improvement Program (CIP) are adjusted.

In order to maintain CAAB's initial funding priorities, staff have developed a draft CIP budget adjustment scenario for BURA to consider at their October 16 meeting date. We would like CAAB to provide input to BURA on the proposed budget adjustment for their consideration. Staff will provide an overview of the proposed budget adjustment and rationale.
