Mayor Pro Tem Perkins Highlights:

6. Old Business:

- a. Commission letter to City of Bend Council: Chair Kitchens He/Him.
 - Chair Kitchens Overview
 - Ian Leitheiser Update to distinction of 24 hours and 72 hours.
 - Member Currie input increase to increase accessibility, not decrease.
 - Would like to see safe parking options, agree, and more about that bolster alternatives before decreasing
 - Information and data as to why changing NIMBY or actual safety, why are we shifting,
 what is the rationale?
 - City Attorney Leitheiser: Police Department Phone Call.
 - Information from City Staff who are in contact with houseless community members
 - **HREC Considering:** standardize the time no, no, go the other way welcome to recommend, keep in mind what Council is considering. Standardize everything at 24, not more. Council has given direction input has the most impact.
 - Member Currie: don't think our commission doing what we are supposed to be doing if
 we say OK. Something is up for change; we are not ok with this change. Change to
 standardize it, do it the other way.
 - **Member Fischer:** Thanks to Agatha and Jeff and Equity support priority from reframe reducing time, wordsmithing. Increasing safe parking options lot more to be done and other ways to tap that.
 - Member Loewenstern: what is the process of removing.
 - **Member Hiemer:** Is there an inventory of items removed.
 - **Member Covington:** Safe parking and item of 30 days (state law and code and property stored for at least 30 days) can be longer.
 - **Member Ventura:** enforcement (I don't think the enforcement changes at all vigilance 2 people applying our camping code) I don't think there is more enforcement this is not going to change straight to enforcement won't change some of the rules will change. **Philosophy will not change camping code, philosophy, none of that is changing.**
 - Police or transportation right of way, non-criminal issue, police are not involved police are not enforcing the camping code.

Chair Kitchens suggested amendments:

- Recommendation 2 acknowledge 72 hours' notice, we suggest not suggesting it to 24 hours.
- Recommendation 2 recommend and encourage city council to ensure consistency, to review camping code, increase to 72 hours to be consistent with parking camping. Notice time,

- Prior to considering decreasing time able to camp in car or tent, would be to balance it with increasing options for safe parking or whatever else would be helpful more shelters etc. safe parking options
- Considering the equity and dignity of all when making the changes not just how we implement, we consider all

Member Ventura and Chair Kitchens to make edits. Thoughts or comments:

Member Fischer: potentially – ADA considerations with ability to remove when needed

• Exceptional Emergency situations – immediate removal – ex: in a driveway, safety issues for multiple people – inherently unsafe, immediate removal, may use public ROW, places that you cannot do this. Describe as inherently dangerous. Immediate removal.

Member Currie: – sounds good,

Chair Kitchens Motioned to amend memo to clarify that we are requesting that the current allowance in camping (reciting entirety of what was just recited). Member Currie second of motion. The motion unanimously passes by all voting members who attended today's meeting, in Chambers (6) and via Zoom (3).
