

  - $\circ$  Safe Haven






## 2024 Point-in-Time Count

**Unsheltered Houselessness** 

Regional Unsheltered 2022: 75% 895 individuals 2023: 72% 1,189 individuals

2024: 66% 1,195 individuals

#### Reported Causes of Houselessness



Unemployment (36.4%) Couldn't afford rent (16.9%)



Other (13.5%)



Eviction (13.2%) Fleeing Domestic Violence (12.3%) Kicked out by family or friends (11%) Problems at property (10%) Substance use in home (8.2%)

### **City of Bend's Response to Houselessness:**

Since the 2023 PIT, 112 shelter beds have been added to the community by the City. Both low and high barrier options.
