

## **Shelter Nights Provided**



Total Nights Provided\*: 69,627

**Utilization Rates:** 

- Lighthouse Navigation Center: 95.03%
- Franklin Avenue Shelter: 93.82%
- Stepping Stone Shelter: 81.04%
- Central Oregon Villages: 75.37%

## **2024 Preliminary Shelter Data**



Unduplicated Clients Served:

- The Lighthouse Navigation Center:
  - Overnight: 537+\*
  - Daytime Average: 327 per month
- Franklin Avenue Shelter: 183
- Stepping Stone Shelter: 94
- Central Oregon Villages: 33

#### **Updated Stepping Stone and Lighthouse Forecast**

Assumptions, if:

 $\odot$  There is no additional funding after FY 24/25

• City funds will be depleted between Fall 2025 and Winter 2026.

Assumptions, if:

 $\odot$  OHCS supports at the same level on FY 25/26

 Stepping Stone and Lighthouse will continue operating until December 31, 2026 (ARPA expires)



#### Supreme Court - City of Grants Pass v. Johnson

- June 28, 2024- Supreme Court issued decision on the City of Grants Pass vs. Johnson
- Reversed the 9<sup>th</sup> Circuit decision that an anti-camping law in Grants Pass violated constitutional protections against cruel and unusual punishment
- Oregon HB 3115 (2021), codified as ORS 195.530, requires that any local regulations on where people can sleep be "objectively reasonable"
  - Any city or county law that regulates the acts of sitting, lying, sleeping or keeping warm and dry outdoors on public property that is open to the public must be objectively reasonable as to time, place and manner with regards to persons experiencing homelessness.
- City of Bend implemented a camping code in early 2023 that complies with 195.530
