### **2. QUASI-JUDICIAL PUBLIC HEARING**

#### **2.1 PLHIS20250125**

**PROPERTY LOCATION:** 500 NW Wall Street; a portion of Block 23 Park Addition subdivision; Tax Lot 08600A1 of Deschutes County Assessor map 17-12-32CA.

**REQUEST:** Historic Review application involving the Bend Amateur Athletic Club also known as the "the Boys and Girls Club" located at 500 NW Wall Street. This is an emergency repair project involving the failing wall at the west main entry stair due to water intrusion and freeze/thaw damage. The proposed repairs include reconstruction of the front entry stairs, ADA ramp and associated masonry elements to correct existing water-related damage and provide safe, building access. The project also includes repair and or replacement of the decorative cast stone panels located at the upper corners of the main building. (Type III Quasi-Judicial Review – Landmarks Commission)
