

ORDINANCE NO. 0002

AN ORDINANCE AMENDING BEND CODE TITLE 17, BEND URBAN RENEWAL AGENCY, CHAPTER 17.10, ADVISORY BOARDS, AND SECTION 17.10.005, CORE AREA ADVISORY BOARD

Findings

- A. On November 3, 2021, the Bend Urban Renewal Agency adopted Ordinance No. 0001, which amended the Bend Municipal Code creating Bend Code Title 17, Bend Urban Renewal Agency, Chapter 17.10, Advisory Boards, and Section 17.10.005, Core Area Advisory Board.
- B. Bend Code Section 17.10.005 outlines the purpose, responsibilities and membership of the Core Area Advisory Board (CAAB) and allows for CAAB to be advised by nonvoting representatives of other agencies. Agency representatives may be named from the Bend Chamber of Commerce and up to five affected taxing districts (including but not limited to Bend-La Pine School District, Bend Park and Recreation District, Deschutes County, Deschutes Library District, and Central Oregon Community College).
- C. The Bend Code does not currently allow agency representation from Central Oregon Intergovernmental Council who owns property within the Core Area and operates Cascade East Transit, the transit authority that serves the City of Bend and Core Area.
- D. On December 15, the Bend Urban Renewal Agency moved to amend the Bend Municipal Code to add Central Oregon Intergovernmental Council as an entity that may name an agency representative to the Core Area Advisory Board.

Based on these findings,

THE BEND URBAN RENEWAL AGENCY ORDAINS AS FOLLOWS:

- Section 1.** Title 17 of the Bend Municipal Code, Chapter 17.10, and Section 17.10.005 are amended as shown on the attached Exhibit A.
- Section 2.** All other provisions of the Bend Municipal Code remain unchanged.
- Section 3.** If any provision, section, phrase, or word of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions that can be given effect without the invalid provision or application.

Agency representatives may be named from the Bend Chamber of Commerce, Central Oregon Intergovernmental Council, and up to five affected taxing districts (including but not limited to Bend-La Pine School District, Bend Park and Recreation District, Deschutes County, Deschutes Library District, and Central Oregon Community College).
