- The final steps for Oregon's 2025 Special Legislative Session regarding its Transportation Package have been delayed. While the House passed HB 3991A, a revenue bill, and HB3992, a budget bill, on September 1, the Senate has been unable to hold a floor session due to the illness of Senator Chris Gorsek.



- During the LOC Annual Business Meeting on October 4, city officials attending the LOC Conference will elect the 2026 LOC Board of Directors. Each city must name their one voting delegate by September 24.
 - ODOT's annual Road and Street Finance Questionnaire collects receipts, expenditures, and debt data required by the Federal Highway Administration. All cities with populations of 5,000+ must complete it to ensure accurate reporting and federal compliance.
 - The LOC is seeking statements of interest for service on its seven policy committees beginning in March 2026. Apply by October 20 to bring your expertise and perspective to help shape the state's legislative agenda.

Bend Airport Receives FAA Funding Award

Bend Municipal Airport is receiving a Federal Aviation Administration (FAA) funded award under the Airport Improvement Program in the amount of \$3,930,621. This grant funds Phase 2 of the Taxiway A and B Rehabilitation Project which provides new taxiway edge lighting along both parallel taxiways to enhance operational safety for aircraft on the ground. Additionally, the project will complete maintenance needed to prolong the life of Bend Airport's two parallel taxiways. The pavement project will maintain the structural integrity of Taxiway A and Taxiway B pavement, minimize debris, and extend the life of the pavement. The edge lighting will enhance operational safety of aircraft on the ground and bring the airport into conformity with current FAA standards. These improvements are part of the City of Bend's continued commitment to the safe and efficient operation of the Bend Airport, the third most active of 97 public use airports in the state of Oregon.

General Obligation Transportation Bond 2025 Annual Report

City of Bend staff and the Transportation Bond Oversight Committee (TBOC) have completed the General Obligation (GO) Transportation Bond 2025 Annual Report. The Bond is intended to fund transportation projects totaling \$190 million to be completed over a ten-year period. Funds from the GO Bond have been used to leverage additional state and federal grant funding to support infrastructure improvements throughout the City. The report summarizes the progress of the Bond program to-date and includes completed and upcoming projects as well as financial metrics. Full report [linked here](#).
