## Diversify Bend's Transportation Future

Transportation is one of the most important issues facing the Bend community. An environmentally sustainable transportation system that supports vibrant neighborhoods that are conveniently served by transit, sidewalks, and bicycle infrastructure can promote healthy lifestyles, provide transportation options for all of Bend's residents, and reduce congestion and greenhouse gas emissions.

The City of Bend is currently updating its Transportation System Plan (TSP), which will be the guiding policy, program, and infrastructure investment document for transportation in Bend until 2040. Any new transportation projects, including those focused on transit, bike lanes, sidewalks, and roads, must be included in this plan. The decisions made between now and the TSP's adoption will determine whether Bend's policies, programs and investments support a healthy, safe, and climate-friendly city or an automobile-centric city with few multi-modal options for residents.

While automobiles are an important part of our transportation infrastructure, they are one of the biggest contributors of greenhouse gas emissions. A balanced transportation system is key to achieving Bend's greenhouse gas reduction goals and will support an economically vibrant community that protects public health and the environment, helps reduce congestion and ensures that all residents can get where they need to go.
