Dear Steering Committee,

The recommendations of CTAC for a future transportation system are encouraging. I would like to highlight the need for non-car-dependent transportation in the future: climate change. Climate change demands we innovate in our transportation sector, and this is the opportunity to do so. The prioritization of near term projects will greatly determine how Bend evolves as a community in years to come. To avoid the most catastrophic consequences of global warming, emissions must be cut drastically in the next decade. So we have 0 time to waste in making climate-conscious decisions. It should be at the forefront of all our decision-making.

But while our hands are tied by this unfolding emergency, we should recognize that this is a great opportunity to positively redefine our community! A non-car-dependent transportation network will greatly increase Bend's quality of life. I'd like to mention some the advantages of non-car-dependent transportation.

- Investment in pedestrian and bike infrastructure and affordable public transit increases casual community interactions in the public sphere; I'm a big believer that these know-your-neighbor interactions foster connections that create a strong communal fabric.
- Accessibility. Affordable public transportation, bike paths, and pedestrian walkways are more equitable than requiring car ownership to take advantage of public infrastructure. These options should be friendly to physically-disabled individuals.
- Besides greenhouse gas emissions, cars also emit other air pollutants, which pose a public health risk.
- Noise pollution from automobile travel is so prevalent now that we barely notice it; but it is degrading to the everyday life of Bendites, except for those who can afford to live further away from major roads.
- Lastly, maintaining roads and parking for automobiles is a huge land-use demand for our city. By investing heavily in non-car transportation (which generally requires less space in our rights-of-way than cars), we can free up space for public tree plantings, which provides a multitude of sustainability and quality-of-life benefits for our city. In fact, trees should go hand-in-hand with new sidewalks and bike paths.

Please adopt CTAC's recommendations and bear my comments in mind when prioritizing projects.
