Metropolitan Transportation Improvement Program (MTIP) -- Public Comment period open --

The Bend Metropolitan Planning Organization (MPO) Policy Board will consider an amendment to the 2021-24 Metropolitan Transportation Improvement Program upon a 21 day public comment period. The meeting will be held on 1/19/2021 or 2/16/2021. The amendment will be considered at a public meeting of the Bend MPO Policy Board. Project Name: US20: Mervin Sampels - Greenwood (3rd St, Bend)

Description: Completing pavement preservation on US 20 from Mervin Samples to Greenwood Ave. Rehab sidewalks, bike lanes, and/or pedestrian/bike paths, ADA ramps, sign improvements, adding crosswalks and a bus stop.

Amendment Number: 21-24-0345

Amendment: Slip the Utility Relocation phase to federal fiscal year 2021 for delivery and reduce the phase by \$300,000, moving the funds to the Construction and Other phases. Add project to the current Statewide Transportation Improvement Program (STIP). This project was in the previous 2018-2021 STIP and was not carried to the current 2021-2024 STIP.

If significant changes to the proposed MTIP are recommended as a consequence, a revised final draft document will be resubmitted to the public for an additional review and comment period. Copies are free of charge and, upon request, will be made available in CD, print, and accessible formats. Upon request, in advance of the meeting, through any of the means listed above, every effort will be made to prepare materials in other formats and in languages other than English, and to provide interpreters in American Sign Language and other languages. Assistive listening devices and large-print materials will be available at the meeting upon request. The Central Oregon Intergovernmental Council (COIC), which is the FTA Section 5307(c) applicant, has consulted with the MPO and concurs that the public involvement process adopted by the MPO for the development of the MTIP satisfies the public hearing requirements that pertain to the development of the Program of Projects for regular Section 5307, Urbanized Area Formula Program, grant applications, including the provision for public notice and the time established for public review and comment.
