


Prescribed Burning 2025

- Reduce severity and intensity of future wildfire.
- Planned for forests surrounding communities, highly-used recreation areas, and boundaries with private property.
- Implemented in areas where forest restoration is needed, and wildfire risk is greatest.
- Conducted under specific conditions temperature, wind, and humidity.



Fuels Reduction – Deschutes River Woods

- Expected date of completion is May 2.
- 136 of the 156 acres have been treated.
- Community Response is very positive, they are very satisfied with the added layer of fire protection.



Fuels Reduction – Juniper Ridge

- Plan is for a 200-foot fuel break (red line).
- Fuel Break:
 - Is a strip of land where vegetation has been reduced to control the spread of fire.
 - Can include a mix of live and low-flammability trees and thinned material.
 - Interrupts the continuity of fuel or the fire path.
- Work to scheduled to begin the week of May 5.

Wildfire Risk Assessments

- Staff and volunteers give professional advice on creating defensible space around homes and on placement of smoke and carbon monoxide alarms.
- *Bend Fire & Rescue by the Numbers:*
 - January – December 2024
 - **115 assessments**
 - January – April 2025:
 - **350 assessments**
 - **100 more scheduled**
- Deschutes County



Flammable Vegetation Code

- Bend - All tenants, property managers, and owners are responsible for reducing potentially flammable vegetation. To help confine fires to the property and prevent them from spreading to neighboring properties.
- Prioritize inspection efforts using data like where we have Firewise communities.
- Different shades of green indicate a reinspection is now needed again on a tax lot.



Fire Season 2025

- Forecast is to maintain normal (low) significant fire potential through June.
- July, is above average for significant fire potential.
- Trends suggest short-term drought conditions could accelerate, leading to rapid fuel drying coinciding with increased human fire activity.
- Weather forecasts are for dryer than normal and warmer than normal conditions

Fire Season 2025

- Response should be similar to 2024
- Safe and coordinated fire response
- All hands, all lands approach
- Regional fire simulation
- Dispatch coordination
- Non-fire agency/organizations

Bend Fire & Rescue is...

- Fully staffed and ready for this fire season.
- Completed annual wildland training, and the apparatus have been serviced and are ready to go.
- Bend Fire has a new Type 6 engine.
- Monitoring the legislative session, especially for continued adequate funding for OSFM.
