

RESOLUTION NO. 3412

A RESOLUTION OF THE CITY COUNCIL SETTING THE RATE OF 15% FOR THE ENTERPRISE ZONE SCHOOL SUPPORT FEE PURSUANT TO HB 2009 (2023)

Findings

- A. HB 2009 was passed in 2023 and was added to and became part of ORS 285C.067;
- B. HB 2009 (2023) requires the governing bodies of the zone sponsors along with the governing body of each school district with territory in the enterprise zone to set a rate for the school support fee imposed pursuant to Sections 45(1)(b), 48(2) and 51(2) of HB 2009 (ORS 285C.067(b));
- C. This rate must be at least fifteen percent (15%) and not more than thirty percent (30%);
- D. The Bend LaPine School District (the "District") has coordinated with the governing bodies of the City of Bend, Deschutes County, and City of LaPine to set the rate;
- E. By District Resolution No. 1961 dated February 13, 2024, the District established the rate of the school support fee of fifteen percent (15%) for the Bend Enterprise Zone;
- F. On June 2, 2021, the City Council passed Resolution 3249 authorizing the Economic Development for Central Oregon (EDCO, Local Zone Manager) to apply for the re-designation of the Bend Enterprise Zone as the previous zone was scheduled to expire on June 30, 2021. The new Enterprise Zone application was approved by Business Oregon and became effective on July 1, 2021. The City of Bend sponsors the Bend Enterprise Zone and EDCO is the zone manager for the Bend Enterprise Zone.
- G. By November 1 in any applicable year, the governing body of the zone sponsor, through City staff or by contracting with its local zone manager (EDCO), will provide the District with all information necessary for the District to collect the fee directly from the business firm;
- H. By December 1 in any applicable year, the District shall send to the business firm a notice of the required fee, with a due date not later than December 31 of the same year;
- I. The District shall be responsible for making refunds to business firms for any overpayments; and

If a fee payment is delinquent for more than sixty (60) days following the date of delinquency or any later date allowed for curing the delinquency, the District Board shall give written notice of the delinquency to the business firm and the Deschutes County Assessor.

Now, therefore, based on these findings,

THE CITY COUNCIL OF THE CITY OF BEND RESOLVES AS FOLLOWS:

1. The Bend LaPine School District Board and the City of Bend (zone sponsor) establish the rate of the school support fee of fifteen percent (15%) for the Bend Enterprise Zone.
2. The City Council authorizes the City Manager to execute any additional documents required to establish the rate of the school support fee at 15 percent (15%).

Adopted by the Bend City Council on December 18, 2024.



 RESOLUTION NO. 1961

Resolution Setting the School Support Fee at 15% for the Bend Enterprise Zone and the Deschutes County Rural Enterprise Zone.

WHEREAS, HB 2009 (2023) was passed in 2023 and became part of ORS 285C.067;

WHEREAS, HB 2009 (2023) requires the governing body of each school district along with the governing body of the zone sponsor to set a rate for the school support fee imposed pursuant to Sections 48 (2) and 51 (2) of HB 2009 (2023);

WHEREAS, this rate must be at least 15 percent and not more than 30 percent;

WHEREAS, the district has coordinated with the governing bodies of the City of Bend (Bend Enterprise Zone) and Deschutes County and City of La Pine (Deschutes County Rural Enterprise Zone) to set the rate;

WHEREAS, by November 1 in any applicable year, the governing body of the zone sponsor will provide the district will all information necessary for the district to collect the fee directly from the business firm;

WHEREAS, by December 1 in any applicable year, the district shall send to the business firm a notice of the required fee, with a due date not later than December 31 of the same year;

WHEREAS, the district shall be responsible for making refunds to business firms of overpayments;

WHEREAS, if a fee payment is delinquent for more than 60 days following the date of delinquency or any later date allowed for curing the delinquency, the Board shall give written notice of the delinquency to the business firm and the assessor of the county;

BE IT THEREFORE RESOLVED that the Bend-La Pine School Board establishes the rate of the school support fee of 15 percent for the Bend Enterprise Zone and the Deschutes County Rural Enterprise Zone .
